and for such other expenses as may be necessarily paid or incurred in the exercise of its powers or performance of its duties, as provided by law shall be paid from the appropriation made to the examining board.

Sec. 2. This act shall be effective the day after final enactment except that the provisions relative to depositing fees in the general fund and the payment of expenses from appropriations shall be effective July 1, 1976.

## CHAPTER 234-H.F.No.600

An act relating to public health; providing for representation of the state examining committee for physical therapists and the advisory council for hospital administrator's registration on the advisory committee on allied health manpower credentialling of the state board of health; amending Minnesota Statutes 1974, Sections 144.571; and 145.865, Subdivision 1.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1974, Section 144.571, is amended to read:

144.571 PUBLIC HEALTH: COMMITTEE MEMBERSHIPS: ADVI-SORY COUNCIL. An advisory board-council of nine members shall be appointed in the following manner to make recommendations to the state board of health and to assist in the establishment of such rules. regulations, and standards and any amendments thereto. This boardcouncil shall consist of four members to be appointed annually from the membership of the Minnesota hospital association by the board of trustees thereof, one of said four members shall be the superintendent of a hospital operated by a county or other local governmental unit; one member representing homes for chronic or convalescent patients shall be appointed annually by the state board of health; and two members shall be doctors of medicine to be appointed annually from the Minnesota state medical association by the council of the Minnesota state medical association. The commissioner of public welfare, or a person from the department of public welfare designated by him, shall be the eighth member of said advisory beard-the council, and the commissioner of public welfare shall designate the ninth member who will represent the Minnesota county welfare boards.

Sec. 2. Minnesota Statutes 1974, Section 145.865, Subdivision 1, is amended to read:

145.865 ADVISORY COMMITTEE. Subdivision 1. The board shall Changes or additions indicated by <u>underline</u> deletions by <del>strikeout</del> Ch. 235

establish an advisory committee to assist in formulating policies pursuant to sections 145.861 to 145.866. The board shall determine the duties of the committee, shall establish procedures for the proper functioning of the committee including, but not limited to the following, the method of selection of membership, the terms of membership, the selection of a committee chairman and methods of communicating recommendations and advice to the board for its consideration. Each of the existing state health-health-related licensing boards as defined in section 214.01, subdivision 2, the state examining committee for physical therapists, the advisory council for hospital administrator's registration, the consumer services section of the department of commerce, the state comprehensive health planning advisory council and the higher education coordinating commission shall have a representative selected by such boards, section or commission. The governor shall appoint the remaining members which shall not exceed eleven and shall include six persons broadly representative of health care services particularly allied health professions not presently licensed, registered or certified pursuant to existing law and five public members unrelated to any health care delivery profession.

An act relating to Voyageurs National Park; establishing and empowering an advisory committee thereon.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MIN-NESOTA:

Section 1. [848.11] VOYAGEURS NATIONAL PARK; CITIZEN'S COMMITTEE. Subdivision 1. The governor shall appoint, except for the legislative members, a citizen's committee on Voyageurs National Park, consisting of 16 members as follows:

Four residents of Koochiching county, two of whom shall be appointed to terms ending January 1, 1979, and two of whom shall be appointed to terms ending January 7, 1980;

Four residents of St. Louis county, two of whom shall be appointed to terms ending January 7, 1980, and two of whom shall be appointed to terms ending January 1, 1979;

Four residents of the state at large from outside Koochiching and St. Louis counties, two of whom shall be appointed to terms ending January 1, 1979, and two of whom shall be appointed to terms ending January 7, 1980;

Changes or additions indicated by underline deletions by strikeout
