
CHAPTER 23—S.F.No.1501

An act relating to game and fish; regulating entry on agricultural lands for taking small or big game; providing a penalty; amending Minnesota Statutes 1974, Section 100.273.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1974, Section 100.273, is amended to read:

100.273 GAME AND FISH; HUNTING CERTAIN GAME; ENTERING UPON AGRICULTURAL LANDS FORBIDDEN. Subdivision 1. During the seasons for taking of ~~pheasants, sharp tailed grouse, ruffed grouse, woodcocks, and snowshoe rabbits~~ small game or big game no person shall enter upon the lands of another which are being used to raise agricultural products or upon land enclosing domestic stock of any kind for the purpose of hunting the above mentioned ~~small~~ game unless and until the permission of the owner or lessee is obtained. Wooded areas other than tree farms shall in no case be construed to be agricultural lands within the meaning of this statute.

Subd. 2. No person while engaged in hunting small game or big game shall destroy, cut or tear down any fence, building, grain, crops, or live trees, or wound or kill any domestic livestock.

Subd. 3. All peace officers shall enforce the provisions of this section.

Subd. 4. Violation of this section is a misdemeanor.

CHAPTER 24—S.F.No.2034

An act relating to natural resources; authorizing the marking and designation of canoe and boating routes on the Straight river; amending Minnesota Statutes 1974, Section 85.32, Subdivision 1.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1974, Section 85.32, Subdivision 1, is amended to read:

85.32 NATURAL RESOURCES; CANOE AND BOATING

ROUTES. Subdivision 1. **AREAS MARKED.** The commissioner of natural resources is authorized in cooperation with local units of government and private individuals and groups when feasible to mark canoe and boating routes on the Little Fork, Big Fork, Minnesota, St. Croix, Snake, Mississippi, Red Lake, Cannon, Straight, Des Moines, Crow Wing, St. Louis, Rum, Kettle, Cloquet, Root and Crow rivers which have historic and scenic values and to mark appropriately points of interest, portages, camp sites, and all dams, rapids, waterfalls, whirlpools, and other serious hazards which are dangerous to canoe and watercraft travelers.

Sec. 2. This act is effective the day following final enactment.

CHAPTER 25—H.F.No.1721

An act relating to education; vocational-technical institutes; providing for student associations.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. [121.216] **EDUCATION; VOCATIONAL-TECHNICAL INSTITUTES; STUDENT ASSOCIATIONS.** Every school board governing an area vocational-technical institute shall give recognition as an authorized extracurricular activity to an area vocational-technical institute student association affiliated with the Minnesota vocational-technical student association. The student association is authorized to collect a reasonable voluntary fee from students to finance the activities of the association in an amount determined by each association after consultation with the governing board of the area vocational-technical institute which has recognized it. No student shall be obligated to pay the fee or be excluded from the association's activities because of failure to pay the fee.

Every governing board which recognizes a student association shall deposit the fees in a student association fund. The moneys in this fund shall be available for expenditure for student recreational, social, welfare, and educational pursuits supplemental to the regular curricular offerings.
