prepare an official record: which shall include testimony and exhibits; in each contested ease, but it shall not be necessary to transcribe shorthand notes unless requested for purposes of rehearing or court review. If a transcript is requested, the agency may, unless otherwise provided by law, require the party requesting to pay the reasonable eosts of preparing the transcript. Prior to assignment of a case to a hearing examiner as provided by section 15.052, all papers shall be filed with the agency. Subsequent to assignment of the case, the agency shall certify the official record to the office of hearing examiners, and thereafter, all papers shall be filed with that office. The office of hearing examiners shall maintain the official record which shall include subsequent filings, testimony and exhibits. All filings are deemed effective upon receipt. Upon issuance of the hearing examiner's report, the official record shall be certified to the agency. Informal disposition may also be made of any contested case by stipulation, agreed settlement, consent order or default. Each agency may adopt appropriate rules of procedure for notice and hearing in contested cases:

Sec. 4. This act shall be effective upon final enactment.

CHAPTER 69—H.F.No.1959

An act authorizing the commissioner of administration to convey a portion of a water system at the Red Wing state training school to the city of Red Wing.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. CONVEYANCE OF STATE LANDS; RED WING, CITY OF. Notwithstanding any law to the contrary, the commissioner of administration may convey by proper instrument in a form approved by the attorney general, to the city of Red Wing, in the name of and on behalf of the state of Minnesota, a portion of the water system at the Red Wing state training school. The conveyance shall be limited to that portion of ten inch water main from the boundary of the school property to a point where it connects to the school's original water system, all located on the training school property.

- Sec. 2. The consideration to be paid by the city of Red Wing for the conveyance shall be determined by the commissioner of administration based upon the appraised value of said portion of the water system and the best interest of the state. The method of payment shall be determined by the commissioner of administration.
- Sec. 3. The commissioner of administration may convey by proper instrument in a form approved by the attorney general, a perpetual

easement to the city of Red Wing for the right of access to, maintenance of, and use of the above described portion of the water system at the Red Wing state training school. Consideration for the easement shall be determined by the commissioner of administration.

CHAPTER 70-H.F.No.1960

An act relating to the firemen's relief association of the city of Goodview; providing that years of service with the Goodview volunteer fire department shall be treated as years of service with the Goodview firemen's relief association; repealing Laws 1974, Chapter 188.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. GOODVIEW, CITY OF; FIREMEN'S RELIEF ASSOCIATION. Notwithstanding any provisions of Minnesota Statutes, Section 69.06, or other law, the city of Goodview shall treat years of service by members of the Goodview volunteer fire department as years of service with the Goodview firemen's relief association for purposes of determining service pensions. This section shall apply only to those persons who became members of the association upon its formation and who continued as members until retirement.

- Sec. 2. Laws 1974, Chapter 188, is repealed.
- Sec. 3. This act shall take effect upon its approval by the governing body of the city of Goodview and upon compliance with the provisions of Minnesota Statutes, Section 645.021.
