

Sec. 2. Minnesota Statutes 1976, Chapter 161, is amended by adding a section to read:

**[161.321] REPORT BY THE COMMISSIONER OF TRANSPORTATION.** The commissioner of transportation shall submit an annual report pursuant to section 3.195, to the governor and the legislature indicating the progress being made toward the objectives and goals of section 1 during the preceding fiscal year. This report shall include the following information:

(a) The total dollar value and number of potential set-aside awards identified during this period and the percentage of total construction work this figure reflects;

(b) The number of small businesses identified and responding to the set-aside program, the total dollar value and number of set-aside contracts actually awarded to small businesses with an approximate designation as to the total number and value of set-aside contracts awarded to each small business, and the total number of small businesses that were awarded set-aside contracts;

(c) The total dollar value and number of set-aside contracts awarded to small businesses owned and operated by economically or socially disadvantaged persons with an approximate designation as to the total number and value of set-aside contracts awarded to each such small business, and the percentages of the total construction work the figures of the total dollar value and the number of set-asides reflect;

(d) The number of contracts which were designated and set aside pursuant to section 1, but which were not awarded to a small business, the estimated total dollar value of these awards, the lowest bid on each of these awards made by a small business and the price at which these contracts were awarded pursuant to the normal procedures.

*An act relating to interim claims against the state; appropriating moneys for the payment thereof; providing for payment of certain claims of inmates of correctional institutions.*

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:**

**Section 1. CLAIMS AGAINST STATE.** Subdivision 1. There is appropriated from the general fund in the state treasury the sums of money set forth in this section to the persons named therein in full and final payment of claims against the state.

Subd. 2. James V. Beal, 7712 Morgan Avenue South, Minneapolis, Minnesota 55423, for legal services performed for the state of Minnesota, department of public

welfare, in behalf of a foster parent pursuant to a written contract that was not properly executed.....\$2,000.

Subd. 3. William Hansen, Route 3, Box 203, Wadena, Minnesota 56482, for loss of animals scared to death by an airplane of the department of natural resources which made low passes over the animal cages at claimant's zoo.....\$2,050.

Subd. 4. Samuel L. Floyd, c/o Stephen K. Erickson, Doyle, Henschel, & Erickson, 605 4th Avenue South, Minneapolis, Minnesota 55415, for injuries sustained in an assault at Stillwater state prison, when the department of corrections failed to provide adequate protection to claimant despite the department's knowledge that claimant was especially likely to be assaulted.....\$750.

Sec. 2. Subdivision 1. There is appropriated from the iron range resources and rehabilitation account in the special revenue fund in the state treasury the sums of money set forth in this section to the persons named therein in full and final payment of claims against the state.

Subd. 2. Richard E. Sec. 5. Unless otherwise specified, payment pursuant to this act shall constitute full and final release of any and all claims against the state of Minnesota.

Sec. 6. **[3.756] DAMAGES TO INMATES.** Subdivision 1. This section is the exclusive remedy for damages to inmates under the control of the commissioner of corrections who are killed or injured while performing assigned duties in any industry or work activity conducted by the state at or in connection with the maintenance or operation of the state's correctional institutions, or their families, heirs, assigns, or next of kin.

Subd. 2. Claims for the payment of compensation to those inmates who may be injured or disabled, or to the dependents of inmates killed, while performing assigned duties in any industry or work activity conducted by the state at or in connection with the maintenance or operation of the state's correctional institutions shall be paid pursuant to legislative appropriation following evaluation of each claim by the appropriate committees

of the senate and house of representatives. Compensation will not be paid for pain and suffering.

Subd. 3. The provisions of section 3.736, subdivision 7, shall, to the extent applicable, govern procedures regarding the giving of notice of a claim under this section.

Sec. 7. This act takes effect upon final enactment.

#### CHAPTER 224—H.F.No.445

*An act relating to natural resources; clarifying procedures for acquisition development, and maintenance of recreational sites along designated canoe and boating routes; amending Minnesota Statutes 1976, Section 85.32, Subdivision 2.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1976, Section 85.32, Subdivision 2, is amended to read:

Subd. 2. **CANOE AND BOAT ROUTES; CAMP SITES, REST AREAS, RIVER ACCESSES AND PORTAGES, LAND ACQUISITION.** The commissioner may, in cooperation with local units of government as provided in subdivision 1, acquire land by purchase, grant, gift, devise, exchange, lease or easement for camp sites, rest areas, river accesses and portages, and develop and maintain such areas along such routes on the rivers designated in subdivision 1; providing that such The acquisition of any parcel of land pursuant to this subdivision acquired shall not exceed 20 acres, unless the acquisition of such parcel of land would it will or should require a land survey or a larger parcel will be in the best interest of the state, in which case the commissioner may acquire a previously surveyed parcel of land not to exceed a quarter-quarter section of land; land not to exceed 40 acres or unless specifically authorized by the legislature executive council. The commissioner may also develop and be responsible for the maintenance of campsites, rest areas, river accesses, and portages on the areas acquired, or in cooperation with local units of government, organizations, or individuals, along those rivers designated in subdivision 1.
