BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **TRUNK HIGHWAY SYSTEM; ROUTE 72.** There is added to the trunk highway system a new route described as follows:

[161.115] Route No. 72. Beginning at a point on Route No. 4, southerly of Bemidji and thence extending in a northerly direction to a point on Route No. 11, easterly of Baudette; affording Bemidji, Waskish, Baudette, and intervening and adjacent communities a reasonable means of communication each with the other and other places within the state.

Sec. 2. The route established in section 1 is a substitute for Route No. 72 as contained and described in Minnesota Statutes 1976, Section 161.115, and said route as so contained and described in said section is discontinued and removed from the trunk highway system.

Sec. 3. The revisor of statutes, in compiling the Minnesota Statutes, shall substitute the route established in section 1 for the route discontinued and removed from the trunk highway system in section 2.

CHAPTER 81—H.F.No.979

*An act relating to state lands; authorizing the conveyance by the state of certain lands in St. Louis county.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **CONVEYANCE OF STATE LANDS; ST. LOUIS COUNTY.** The commissioner of revenue is hereby authorized to convey to St. Louis county, free of any and all restriction or reservation whatsoever, by quitclaim deed in the form the attorney general approves the following described lands situate in St. Louis county, described as follows, to wit:

Lots Seven (7) and Eight (8), including part of vacated Branch Street adjoining, in Block Seventeen (17), NEW ENDION DIVISION OF DULUTH, according to the required plat thereof.

St. Louis county is authorized to sell such land and premises upon such terms as it deems fitting and proper and credit the proceeds to St. Louis county historical society.

Sec. 2. This act will become effective upon approval of St. Louis county board of

## CHAPTER 82—S.F.No.617

*An act relating to the university of Minnesota; conferring university of Minnesota peace officers with limited powers of arrest; governing the operation and parking of vehicles upon property owned, leased or occupied by the regents of the university of Minnesota; amending Minnesota Statutes 1976, Sections 137.12; 169.123, Subdivision 1; 169.965, Subdivision 1; 626.05, Subdivision 2; 626A.01, Subdivision 7; and Chapter 626, by adding a section.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1976, Section 137.12, is amended to read:

**137.12 UNIVERSITY OF MINNESOTA; PEACE OFFICERS; POWERS OF ARREST.** The regents of the University of Minnesota are hereby authorized to appoint, employ and fix the compensation to be paid out of funds of the regents of the University of Minnesota, persons as ~~investigators~~ peace officers who shall have and may exercise throughout the state of Minnesota the same powers of arrest possessed by a sheriff, police officer, or peace officer, but said powers of arrest shall only be exercised in connection with investigations authorized to be made by the regents of the University of Minnesota, which investigations shall relate to university personnel or property.

Sec. 2. Minnesota Statutes 1976, Section 169.123, Subdivision 1, is amended to read:

**169.123 CHEMICAL TESTS FOR INTOXICATION.** Subdivision 1. **PEACE OFFICER DEFINED.** For purposes of this section and section 169.121, subdivision 2, the term peace officer means a state highway patrol officer, university of Minnesota peace officer, or full time police officer of any municipality, including towns having powers under section 368.01, or county having satisfactorily completed a prescribed course of instruction in a school for instruction of persons in law enforcement conducted by the University of Minnesota or a similar course considered equivalent by the commissioner of public safety.

Sec. 3. Minnesota Statutes 1976, Section 169.965, Subdivision 1, is amended to read:

**169.965 REGENTS OF UNIVERSITY OF MINNESOTA TO REGULATE TRAFFIC.** Subdivision 1. The regents of the University of Minnesota may, from time to time, make, adopt and enforce such rules, regulations or ordinances as it may find expedient or necessary relating to the regulation of traffic ~~pursuant to the highway traffic regulation act; chapter 169; as amended and parking, upon parking facilities, highways,~~
