CHAPTER 481-H.F.No.935

An act relating to counties; including the board of county commissioners of Ramsey county among those county boards that may set expense allowances for members of certain boards and agencies; amending Minnesota Statutes 1976, Section 375.47, Subdivision 1.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1976, Section 375.47, Subdivision 1, is amended to read:

375.47 EXPENSE ALLOWANCES FOR MEMBERS OF BOARDS AND AGENCIES. Subdivision 1. Except in <u>Hennepin and Saint Louis</u> counties containing a eity of the first elass, the board of county commissioners of each county may, by resolution, set a reasonable allowance for expenses or a per diem allowance in lieu of expenses and a mileage allowance to be paid the members of boards or agencies authorized by statute, and members of advisory boards or committees, performing duties for all or part of the county, when the board or agency does not itself have power to make expense allowances for its members. The allowances shall be paid from the funds under the administration of the boards or agencies. Members of the board of county commissioners shall not receive any per diem pursuant to this subdivision.

CHAPTER 482-H.F.No.1095

An act relating to public health; requiring medical malpractice information from insurers; granting subpoena power to the board of medical examiners; amending Minnesota Statutes 1976, Section 147.072.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1976, Section 147.072, is amended to read:

147.072 MALPRACTICE REPORTS FROM INSURERS. <u>Subdivision 1.</u> MALPRACTICE REPORTING. Four times each year as prescribed by the board, each insurer authorized to sell insurance described in section 60A.06, subdivision 1, clause (13), and providing professional liability insurance to physicians shall submit to the board a report concerning the physicians against whom medical malpractice settlements or awards have been made to the plaintiff. The report shall contain but not be limited to the following information:

(a) The total number of medical malpractice settlements or awards made to the plaintiff;
