

Subdivision 1. MILK PRODUCT MARKETING STUDY. The commissioner of agriculture shall institute a study of the current marketing practices for milk and milk products as defined in Minnesota Statutes, Section 32.391. The commissioner shall review the milk and milk product packaging practices of dairies in Minnesota in the following areas:

(1) The economic effect on consumers of milk and milk products, dairy farmers and the dairy industry of a ban on use of each of the various packaging devices for fluid milk and milk products produced or used in Minnesota;

(2) The sanitation, nutritional, energy and natural resource implications of the various milk and milk product packaging devices; and

(3) Other factors the commissioner deems appropriate.

The commissioner shall prepare this study and report his findings to the legislature in 1982.

Subd. 2. COST OF STUDY. The cost of the study authorized in subdivision 1 shall be paid from gifts voluntarily contributed for this purpose prior to the initiation of the study. Pursuant to Minnesota Statutes, Sections 7.09 to 7.12, the commissioner may accept and expend these gifts of money for the funding of this study.

#### **Sec. 2. REPEALER.**

Minnesota Statutes 1980, Sections 116F.21 and 116F.22 are repealed.

#### **Sec. 3. EFFECTIVE DATE.**

This act is effective the day following final enactment.

### **CHAPTER 152 — S.F.No. 1259**

*An act relating to Independent School District No. 281, Robbinsdale; providing an alley system for at large election of school board members.*

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:**

#### **Section 1. ALLEY SYSTEM.**

Subdivision 1. ESTABLISHMENT. The board of Independent School District No. 281, Robbinsdale, may by resolution establish an alley system for the at large election of board members.

Subd. 2. NOTICE. If the board establishes an alley system, the notice of election shall include substantially the following form:

**Changes or additions are indicated by underline, deletions by ~~strikeout~~.**

"Position number 3 and position number 5 are to be filled by election. Candidates may not file for more than one position."

Subd. 3. **APPLICATIONS.** If the board establishes an alley system, every application for candidacy to the board shall specify the numbered position for which the applicant is filing.

Subd. 4. **BALLOTS.** If the board establishes an alley system, the ballots shall read as follows:

"For school board position number 3 of Independent School District Number 281" or "For school board position number 5 of Independent School District Number 281."

The names of the candidates for each seat shall be rotated on the ballots to avoid any appearance of preference for incumbents. Incumbency shall not be indicated on the ballot.

Subd. 5. **DISCONTINUANCE.** The board may at any time by resolution discontinue the alley system.

Subd. 6. **INCUMBENTS.** If the board establishes or discontinues an alley system, incumbents shall serve the entire terms to which they were elected under the prior system. If the board establishes an alley system, incumbents shall be assigned by lot to the numbered positions.

## Sec. 2. **APPLICABILITY.**

On its effective date, section 1 applies to Independent School District No. 281, Robbinsdale.

## Sec. 3. **EFFECTIVE DATE.**

Pursuant to Minnesota Statutes, Section 645.023, Subdivision 1, Clause (a), section 1 is effective without local approval on the day after final enactment.

## CHAPTER 153 — H.F.No. 57

*An act relating to real estate; directing a conveyance of the state's right, title and interest in certain lands to Independent School District No. 417 of Tracy, Minnesota.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

### Section 1. **CONVEYANCE OF LAND; TRACY ATHLETIC FIELD.**

The commissioner of revenue shall convey, without monetary consideration, by quitclaim deed in a form approved by the attorney general to
