

**CHAPTER 408—H.F.No. 2309**

*An act relating to highways; changing highway description; amending Minnesota Statutes 1992, section 161.115, subdivision 224.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1992, section 161.115, subdivision 224, is amended to read:

Subd. 224. **ROUTE NO. 293.** Beginning at a point on Route No. 132 in Cambridge; thence extending in a general southerly direction through the grounds of the Cambridge State School and Hospital to a point on old Route No. 5.

**Sec. 2. EFFECTIVE DATE.**

Section 1 is effective when an agreement to transfer jurisdiction of a portion of old Legislative Route No. 5 in the city of Cambridge (pending completion of new Route No. 5 around the city) has been agreed to and signed by the commissioner of transportation, the governing body of the city of Cambridge, and the Isanti county board, and filed in the office of the commissioner.

**CHAPTER 409—H.F.No. 1913**

*An act relating to retirement; St. Paul police consolidation account; authorizing the payment of refunds to the estates of certain deceased police officers.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

**Section 1. ST. PAUL POLICE CONSOLIDATION ACCOUNT; REFUND IN CERTAIN INSTANCES.**

(a) Upon filing a written application by an applicable heir, the St. Paul police consolidation account may pay, in equal shares if there is more than one heir, a refund of member contributions and interest, as specified in Minnesota Statutes, section 423A.18, paragraph (b), to the direct lineal heir or heirs of the person described in paragraph (b).

(b) The person referenced in paragraph (a) is a person who:

(1) was a police officer employed by the city of St. Paul and a member of the St. Paul police relief association;

(2) was born on February 4, 1941; and

(3) died on May 1, 1990.

(c) It is expressly intended that Minnesota Statutes, section 423A.18, be retroactive in its application to this instance.

**Sec. 2. EFFECTIVE DATE.**

Section 1 is effective on the day following final approval by the city council of the city of St. Paul and compliance with Minnesota Statutes, section 645.021.

**CHAPTER 410—H.F.No. 1881**

*An act relating to the city of Red Wing; authorizing certain police officers to elect retirement coverage by the public employees police and fire fund.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

**Section 1. RED WING POLICE; RETIREMENT COVERAGE.**

Notwithstanding the 180-day limitation contained in Minnesota Statutes, section 353A.08, subdivision 3, an active member of the Red Wing police relief association may make an election to have retirement benefit coverage provided by the public employees police and fire fund as authorized by the cited law. An election under this section must be made within 90 days after the effective date of this section, and shall in all other respects be governed by Minnesota Statutes, section 353A.08, and other applicable laws.

**Sec. 2. LOCAL APPROVAL.**

Section 1 is effective on approval by the Red Wing city council and compliance with Minnesota Statutes, section 645.021.
