In the column labelled "Chapter," the numbers and abbreviation 94 1Sp1 indicate the 1994 First Special Session chapter 1, and the numbers and abbreviations 1Sp1, 1Sp2, and 1Sp3 indicate the 1995 First Special Session chapters 1, 2, and 3.

Sections marked (N) were enacted at the 1995 regular session, the 1995 First Special Session, or the 1994 First Special Session. Sections enacted at the 1995 regular session and 1995 First Special Session will be included in the 1995 Minnesota Statutes Supplement and Minnesota Statutes 1996. Sections enacted at the 1994 First Special Session were included in Minnesota Statutes 1994.

For the 1995 regular session and 1995 First Special Session, Amendments and Repeals refer to changes that affect sections of Minnesota Statutes 1994 that will be included in the 1995 Minnesota Statutes Supplement and Minnesota Statutes 1996. For the 1994 First Special Session, Amendments and Repeals refer to changes that affect sections of Minnesota Statutes 1992 or, if marked by an asterisk, to changes that affect Minnesota Statutes 1993 Supplement.

Legislative action that does not fit the categories "New," "Amendment," or "Repeal" is designated "Other action."
