All other laws listed in the table contain express requirements of local approval or are laws for which local approval certificates were filed regardless of whether the filing was required.

If a local approval certificate has been filed with the Secretary of State in compliance with Minnesota Statutes, section 645.021, by June 21, 2017, the approval and filing dates are indicated. A blank space after a chapter citation indicates that a local approval certificate had not been filed by June 21, 2017.

For any special law enacted in 2017 or 2018 that requires local approval, the certificate of approval must be filed with the Secretary of State before the first day of the legislative session in 2019, or, pursuant to Minnesota Statutes, section 645.021, subdivision 3, the law is deemed to be disapproved by the local government unit unless otherwise provided in a special law.
