(A) indicates an amendment either to an existing section or to a section newly enacted this year. (R) indicates a repeal.

Sections marked (N) were first enacted at the 2020 Regular Session or 2020 First Special Session or 2020 Second Special Session or 2020 Third Special Session. Those sections will be included in full in the 2020 Minnesota Statutes.

Sections marked (A) or (R) are existing sections of Minnesota Statutes.

Legislative action not fitting the categories "Amendment," "Repeal," and "New" is designated "Other action."

Chapter references to "1Sp" designate laws passed in the 2020 First Special Session. Chapter references to "2Sp" designate laws passed in the 2020 Second Special Session. Chapter references to "3Sp" designate laws passed in the 2020 Third Special Session. All other chapter references are to laws passed in the 2020 Regular Session.
