**No laws were enacted at the Fourth and Sixth Special Sessions in 2020**

This table lists special laws enacted in 2020 relating to local government units if there is an express statement in the special law that local approval is required or not required or if for any reason the local government unit has filed a certificate of local approval with the Secretary of State.

If the special law expressly states that local approval is not required, the term "Not required" appears to the right of the chapter citation. All other laws listed in the table contain express requirements of local approval or are laws for which local approval certificates were filed regardless of whether the filing was required.

If a local approval certificate has been filed with the Secretary of State in compliance with Minnesota Statutes, section 645.021, the approval and filing dates are indicated. A blank space after a chapter citation indicates that a local approval certificate had not been filed by January 5, 2021.

For any special law enacted in 2020 that requires local approval, the certificate of approval must be filed with the Secretary of State before January 5, 2021, the first day of the legislative session in 2021, or, pursuant to Minnesota Statutes, section 645.021, subdivision 3, the law is deemed to be disapproved by the local government unit unless otherwise provided in a special law.
