

CHAPTER 72--H.F.No. 669

An act relating to capital investment; authorizing spending to acquire and better public land and buildings and for other improvements of a capital nature with certain conditions; establishing new programs and modifying existing programs; modifying prior appropriations; authorizing the sale and issuance of state bonds; authorizing the conveyance of state bond-financed property; requiring reports; appropriating money; amending Minnesota Statutes 2022, sections 116J.417, subdivision 2; 174.38, subdivisions 1, 3; Laws 2018, chapter 214, article 1, sections 7, subdivisions 7, 9, 11, 18; 16, subdivisions 14, 19, as amended; 17, subdivision 7, as amended; 18, subdivision 5; 21, subdivisions 17, 29, as amended; Laws 2020, Fifth Special Session chapter 3, article 1, sections 7, subdivisions 12, 18, as amended, 24; 15, subdivision 6; 16, subdivisions 4, 11, 25, 26; 17, subdivisions 7, 13; 20, subdivision 11; 21, subdivisions 17, 36, 46, 48; 22, subdivisions 15, 33, as amended; article 3, section 2, subdivision 2.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

ARTICLE 1**APPROPRIATIONS****Section 1. CAPITAL IMPROVEMENT APPROPRIATIONS.**

(a) The sums shown in the column under "Appropriations" are appropriated from the bond proceeds fund, or another named fund, to the state agencies or officials indicated, to be spent for public purposes. Appropriations of bond proceeds must be spent as authorized by the Minnesota Constitution, article XI, section 5, clause (a), to acquire and better public land and buildings and other public improvements of a capital nature, or as authorized by the Minnesota Constitution, article XI, section 5, clauses (b) to (j), or article XIV. Unless otherwise specified, money appropriated in this act:

(1) may be used to pay state agency staff costs that are attributed directly to the capital program or project in accordance with accounting policies adopted by the commissioner of management and budget;

(2) is available until the project is completed or abandoned subject to Minnesota Statutes, section 16A.642;

(3) for activities under Minnesota Statutes, sections 16B.307, 84.946, and 135A.046, should not be used for projects that can be financed within a reasonable time frame under Minnesota Statutes, section 16B.322 or 16C.144;

(4) is subject to the policies and procedures adopted by the commissioner of management and budget or otherwise specified in applicable law; and

(5) is available for a grant to a political subdivision after the commissioner of management and budget determines that an amount sufficient to complete the project as described in this act has been committed to the project, as required by Minnesota Statutes, section 16A.502.

(b) Unless otherwise specified, appropriations in this article from the general fund are made in fiscal year 2024 and are onetime appropriations.

(c) Recipients of grants from money appropriated in this article must demonstrate to the commissioner of the agency making the grant that the recipient has the ability and a plan to fund the program intended for the facility. This paragraph does not apply to state agencies.

APPROPRIATIONS

Sec. 2. UNIVERSITY OF MINNESOTA

Subdivision 1. Total Appropriation

\$ 135,950,000

To the Board of Regents of the University of Minnesota for the purposes specified in this section.

Subd. 2. Higher Education Asset Preservation and Replacement (HEAPR)

43,350,000

To be spent in accordance with Minnesota Statutes, section 135A.046.

Subd. 3. Twin Cities - Chemistry Undergraduate Teaching Laboratory

92,600,000

To construct, furnish, and equip the renovation of and an addition to Fraser Hall for an undergraduate chemistry teaching laboratory facility on the Twin Cities campus. This project includes the demolition of obsolete portions of Fraser Hall.

Subd. 4. University Share

Except for the appropriations for HEAPR, the appropriations in this section are intended to cover approximately two-thirds of the cost of each project. The remaining costs must be paid from university sources.

Subd. 5. Unspent Appropriations

Upon substantial completion of a project authorized in this section and after written notice to the commissioner of management and budget, the Board of Regents must use any money remaining in the appropriation for that project for HEAPR under Minnesota Statutes, section 135A.046. The Board of Regents must report by February 1 of each even-numbered year to the chairs of the house of representatives and senate committees with jurisdiction over capital investment and higher education finance,

and to the chairs of the house of representatives Ways and Means Committee and the senate Finance Committee, on how the remaining money has been allocated or spent.

Sec. 3. MINNESOTA STATE COLLEGES AND UNIVERSITIES

Subdivision 1. Total Appropriation **\$ 179,752,000**

To the Board of Trustees of the Minnesota State Colleges and Universities for the purposes specified in this section.

Subd. 2. Higher Education Asset Preservation and Replacement (HEAPR) **44,733,000**

To be spent in accordance with Minnesota Statutes, section 135A.046.

Subd. 3. Minnesota State University, Moorhead **23,099,000**

To design, renovate, expand, and equip Weld Hall, including the construction of additions to improve building accessibility at Minnesota State University, Moorhead.

Subd. 4. Inver Hills Community College **22,025,000**

To design, renovate, and equip the Technology and Business Center building, including the construction of a link to Heritage Hall at Inver Hills Community College.

Subd. 5. Minneapolis Community and Technical College **20,457,000**

To design, renovate, and equip phases 1 and 2 of the Management Education Center shared with Metropolitan State University on the Minneapolis Community and Technical College campus to support baccalaureate programming expansion.

Subd. 6. Pine Technical and Community College **21,468,000**

To design, renovate, construct, and equip the renovation of the main building allied health space and an addition of the technical trade and applied learning labs at Pine Technical and Community College.

Subd. 14. Metropolitan State**5,196,000**

To design, renovate, and equip space in New Main Hall for the cybersecurity program at Metropolitan State University.

Subd. 15. Alexandria Technical and Community College**955,000**

To design the renovation of student services spaces, the demolition of obsolete campus space, which will be replaced by the new renovated student services space and the new Transportation Center, and to design the construction of the Transportation Center at Alexandria Technical and Community College.

Subd. 16. Debt Service

(a) Except as provided in paragraph (b), the Board of Trustees shall pay the debt service on one-third of the principal amount of state bonds sold to finance projects authorized by this section. After each sale of general obligation bonds, the commissioner of management and budget shall notify the board of the amounts assessed for each year for the life of the bonds.

(b) The board need not pay debt service on bonds sold to finance HEAPR. Where a nonstate match is required, the debt service is due on a principal amount equal to one-third of the total project cost, less the match committed before the bonds are sold.

(c) The commissioner of management and budget shall reduce the board's assessment each year by one-third of the net income from investment of general obligation bond proceeds in proportion to the amount of principal and interest otherwise required to be paid by the board. The board shall pay its resulting net assessment to the commissioner of management and budget by December 1 each year. If the board fails to make a payment when due, the commissioner of management and budget shall reduce allotments for appropriations from the general fund otherwise available to the board and apply the amount of the reduction to cover the missed debt service payment. The commissioner of management and budget shall credit the payments received from the board to the bond debt service account in the state bond fund each December 1 before money is transferred from the

general fund under Minnesota Statutes, section 16A.641, subdivision 10.

Subd. 17. Unspent Appropriations

(a) Upon substantial completion of a project authorized in this section and after written notice to the commissioner of management and budget, the board must use any money remaining in the appropriation for that project for HEAPR under Minnesota Statutes, section 135A.046. The Board of Trustees must report by February 1 of each even-numbered year to the chairs of the house of representatives and senate committees with jurisdiction over capital investment and higher education finance and to the chairs of the house of representatives Ways and Means Committee and the senate Finance Committee, on how the remaining money has been allocated or spent.

(b) The unspent portion of an appropriation for a project in this section that is complete is available for HEAPR under this subdivision, at the same campus as the project for which the original appropriation was made and the debt service requirement under this section is reduced accordingly. Minnesota Statutes, section 16A.642, applies from the date of the original appropriation to the unspent amount transferred.

Sec. 4. **EDUCATION** **\$ 4,000,000**

To the commissioner of education for library construction grants under Minnesota Statutes, section 134.45.

Sec. 5. **MINNESOTA STATE ACADEMIES**

Subdivision 1. **Total Appropriation** **\$ 9,037,000**

To the commissioner of administration for the purposes specified in this section.

Subd. 2. **Asset Preservation** **1,200,000**

For capital asset preservation improvements and betterments on both campuses of the Minnesota State Academies, to be spent in accordance with Minnesota Statutes, section 16B.307.

Subd. 3. Dorm Renovations and Predesign**7,837,000**

To predesign, design, construct, furnish, and equip the renovation of Kramer Hall, Brandeen Hall, and Rode Hall Dorms on the Blind School Campus, including but not limited to abatement of asbestos and hazardous materials, construction, and renovations required to improve safety and security for occupants, meet ADA requirements, meet energy saving requirements, and improve indoor air quality standards. This appropriation also includes money to predesign, design, construct, furnish, and equip the renovation of Pollard Hall Dorm on the Deaf School Campus, including but not limited to abatement of asbestos and hazardous materials, construction, and renovations required to improve safety and security for occupants, meet ADA requirements, meet energy saving requirements, and improve indoor air quality standards.

Sec. 6. PERPICH CENTER FOR ARTS EDUCATION**\$ 900,000**

To the commissioner of administration for capital asset preservation improvements and betterments at the Perpich Center for Arts Education, to be spent in accordance with Minnesota Statutes, section 16B.307.

Sec. 7. NATURAL RESOURCES**Subdivision 1. Total Appropriation****\$ 196,880,000**

(a) To the commissioner of natural resources for the purposes specified in this section.

(b) The appropriations in this section are subject to the requirements of the natural resources capital improvement program under Minnesota Statutes, section 86A.12, unless this section or the statutes referred to in this section provide more specific standards, criteria, or priorities for projects than Minnesota Statutes, section 86A.12.

Subd. 2. Natural Resources Asset Preservation**36,000,000**

For the preservation and replacement of state-owned facilities and recreational assets operated by the commissioner of natural resources to be spent in accordance with Minnesota Statutes, section 84.946.

Subd. 3. **Betterment of Buildings** 20,000,000

For acquisition, predesign, design, and construction to replace existing facilities that no longer meet the business needs of the department or to acquire or construct new facilities.

Subd. 4. **Badoura State Forest Nursery** 10,000,000

For the predesign, design, and construction of facility capital improvements and associated facility components at the Badoura State Forest Nursery.

Subd. 5. **Wildfire Aviation Infrastructure** 6,360,000

For site preparation, predesign, design, engineering, demolition, construction, furnishing, and equipping new public safety facilities for aerial wildfire suppression, which may include grants to airport authorities. This appropriation includes money for the Hibbing airport and air tanker base buildings and associated utilities and systems.

Subd. 6. **Accessibility** 1,200,000

For the design and construction of accessibility improvements at state parks, recreation areas, and wildlife management areas.

Subd. 7. **Dam Renovation, Repair, Removal** 4,000,000

(a) For design, engineering, and construction to repair, reconstruct, or remove publicly owned dams and respond to dam safety emergencies on publicly owned dams. The commissioner shall determine project priorities as appropriate under Minnesota Statutes, sections 103G.511 and 103G.515.

(b) If the commissioner determines that a project is not ready to proceed, this appropriation may be used for other projects on the commissioner's priority list.

Subd. 8. **Flood Hazard Mitigation** 40,300,000

(a) For the state share of flood hazard mitigation grants for publicly owned capital improvements to prevent or alleviate flood damage under Minnesota Statutes, section 103F.161. To the extent practical, levee

projects shall meet the state standard of three feet above the 100-year flood elevation.

(b) Project priorities shall be determined by the commissioner as appropriate, based on need and consideration of available leveraging of federal, state, and local funds.

(c) Notwithstanding paragraph (b), \$3,300,000 of this appropriation is for Phase II of the Toelle Coulee project in Traverse County to mitigate flood risks posed to the city of Browns Valley, including construction of an East Levee, County State-Aid Highway 2 culvert replacement, and marked Trunk Highway 28 culvert replacement.

(d) Notwithstanding paragraph (b), \$5,000,000 of this appropriation is for grants to watershed districts that are members of the Red River Watershed Management Board for flood mitigation projects and is not for projects in the city of Moorhead.

(e) Notwithstanding paragraph (b), \$11,000,000 is for a grant to the city of Moorhead to design, construct, and equip flood mitigation infrastructure. This appropriation includes money for Phase 2 of the North Moorhead levee project, the relocation of sanitary lift station #2, and a levee project along First Avenue North.

(f) Notwithstanding paragraph (b), \$6,000,000 is from the general fund for a grant to the city of Carver for capital improvements to restore the Carver levee protecting an important historic district in Minnesota from flood waters of the Minnesota River. This levee restoration must meet the requirements for FEMA certification. The project includes predesign, design, engineering, land acquisition, and construction of capital improvements, including raising the height of the Carver levee, constructing internal drainage, establishing maintainable setbacks to adjacent structures, and certification by FEMA.

(g) To the extent practicable and consistent with the project, recipients of appropriations for flood control projects in this subdivision shall create wetlands that are eligible for wetland replacement credit to replace wetlands drained or filled as the result of repair, reconstruction, replacement, or rehabilitation of an

existing public road under Minnesota Statutes, section 103G.222, subdivision 1, paragraphs (l) and (m).

(h) To the extent that the cost of a municipal project exceeds two percent of the median household income in the municipality multiplied by the number of households in the municipality, this appropriation is also for the local share of the project.

Subd. 9. Lake Vermilion-Soudan Underground Mine State Park

11,000,000

For the design and construction of a visitor center, camping facilities and boardwalk, hiking and biking trails, dock and fishing pier, and related infrastructure; the design of the Mattson Bay Camp and Soudan Heritage and Science Center; and the rehabilitation of a fire tower at Lake Vermilion-Soudan Underground Mine State Park.

Subd. 10. Parks and Trails Local and Regional Recreation Grants

2,000,000

For matching grants under Minnesota Statutes, section 85.019.

Subd. 11. Community Tree Planting Grants

8,400,000

For grants to cities, counties, townships, and park and recreation boards in cities of the first class, to remove and plant shade trees on public land to provide environmental benefits; to replace trees lost to forest pests, disease, or storm; or to establish a more diverse community forest better able to withstand disease and forest pests. For purposes of this appropriation, "shade tree" means a woody perennial grown primarily for aesthetic or environmental purposes with minimal to residual timber value. Any tree planted with money under this subdivision must be a climate-adapted species to Minnesota.

Subd. 12. St. James Open Pit Mine Complex

2,500,000

For predesign, design, and engineering of capital improvement projects to mitigate the imminent threat to public safety, property, and regional water quality from the rising water levels at the St. James open pit mine complex.

<u>Subd. 13. Reforestation</u>	<u>6,000,000</u>
<u>For reforestation and stand improvement on state forest lands to meet the reforestation requirements of Minnesota Statutes, section 89.002, subdivision 2, including purchasing native seeds and native seedlings, planting, seeding, site preparation, and protection on state lands administered by the commissioner.</u>	
<u>Subd. 14. State Trail Maintenance</u>	<u>1,200,000</u>
<u>To renovate paved and unpaved state trails established under Minnesota Statutes, section 85.015, according to the commissioner's priorities and as provided in Minnesota Statutes, section 84.946.</u>	
<u>Subd. 15. Casey Jones State Trail</u>	<u>1,320,000</u>
<u>For acquisition, design, engineering, and construction of the Casey Jones State Trail under Minnesota Statutes, section 85.015, subdivision 2. The Casey Jones State Trail must be established as a primary, not a secondary trail.</u>	
<u>Subd. 16. Gitchi Gami State Trail</u>	<u>4,000,000</u>
<u>For acquisition, design, engineering, and construction of the Gitchi Gami State Trail priority segments: Lutsen from Ski Hill Road, Tofte, Silver Bay to Tettegouche State Park, and Two Harbors to Flood Bay State Wayside.</u>	
<u>Subd. 17. Glacial Lakes Trail</u>	<u>3,000,000</u>
<u>To design and construct the final trail segment for the Glacial Lakes Trail, established under Minnesota Statutes, section 85.015, subdivision 5, between the city of New London and Sibley State Park.</u>	
<u>Subd. 18. Heartland State Trail</u>	<u>2,950,000</u>
<u>(a) For capital improvements to the Heartland State Trail. Of this amount, (1) \$550,000 is for construction of a trail segment of the Heartland State Trail between Detroit Lakes and Frazee; and (2) \$2,400,000 is for the environmental review, predesign, design, and construction of a paved multiple-use trail to connect Itasca State Park to the Heartland State Trail beginning</u>	

from the park contact station to the park's southeast boundary and through a Phase 1 tunnel to be constructed under marked U.S. Highway 71, and continuing from there for about two miles.

(b) This appropriation is in addition to the appropriations in Laws 2017, First Special Session chapter 8, article 1, section 6, subdivision 6, and Laws 2020, Fifth Special Session chapter 3, article 1, section 7, subdivision 12.

Subd. 19. Mill Towns State Trail

8,190,000

For land acquisition, predesign, design, and construction of the Mill Towns State Trail between Riverside Park in the city of Northfield and the Waterford Historic Bridge in Waterford Township.

Subd. 20. Root River State Trail; Preston to Carimona

2,000,000

For acquisition of property, design, and engineering of the Root River State Trail under Minnesota Statutes, section 85.015, from the city of Preston to the city of Carimona.

Subd. 21. Glendalough State Park

900,000

To complete the paved multipurpose trail from the bridge at the northwest corner of Annie Battle Lake to the park entrance at Glendalough State Park.

Subd. 22. Upper Sioux Agency State Park Bond Defeasance

250,000

From the general fund to the commissioner of management and budget to prepay and defease any outstanding state general obligation bonds used for improvements and betterments at Upper Sioux Agency State Park, including Minnesota Historical Society property located within the park's boundaries, and other associated financing costs. This amount may be deposited, invested, and applied to accomplish the purposes of this section as provided in Minnesota Statutes, section 475.67, subdivisions 5 to 10 and 13. Upon the prepayment and defeasance of all associated debt on the real property and improvements, all conditions set forth in Minnesota Statutes, section 16A.695, subdivision 3, shall be deemed to have been satisfied and the real property and improvements shall

no longer constitute state bond financed property under Minnesota Statutes, section 16A.695.

Subd. 23. Lower Minnesota River Watershed District; Minnesota River Riverbank Stabilization

2,750,000

For a grant to the Lower Minnesota River Watershed District for final design and construction of capital improvements necessary to stabilize the riverbank, prevent erosion, and prevent future degradation of the water quality of the Minnesota River resulting from Area 3 bank erosion in the city of Eden Prairie.

Subd. 24. Mora; High Water Mitigation

1,800,000

For a grant to the city of Mora to design and construct improvements to mitigate high water in Mora Lake, including installation of intake and outlet structures, and associated sanitary sewer and road replacement.

Subd. 25. Ranier; Rainy Lake Marina

3,500,000

For a grant to the city of Ranier to predesign, design, engineer, construct, and equip a marina to provide up to 26 slips in a safe harbor on Rainy Lake and Rainy River at the Gateway to Voyageurs National Park. The marina will provide overnight transient boaters with water, electricity, and pump-out services.

Subd. 26. Shakopee; Minnesota River Riverbank Stabilization

8,260,000

For a grant to the city of Shakopee to predesign, design, and construct the restoration of the Minnesota River riverbank from the western edge of downtown Shakopee to The Landing in the Three Rivers Park District.

Subd. 27. Shell Rock River Watershed District; Fountain Lake

9,000,000

For a grant to the Shell Rock River Watershed District for sediment removal and cleanup of Fountain Lake.

Subd. 28. Unspent Appropriations

The unspent portion of an appropriation for a project in this section that is complete, upon written notice to the commissioner of management and budget, is

available for asset preservation under Minnesota Statutes, section 84.946. Minnesota Statutes, section 16A.642, applies from the date of the original appropriation to the unspent amount transferred.

Sec. 8. POLLUTION CONTROL AGENCY

10,000,000

To the Pollution Control Agency for a capital assistance grant to Olmsted County under Minnesota Statutes, section 115A.54, to design, construct, and equip a new materials recovery facility which will expand upon the county's current integrated solid waste management system by reclaiming materials and removing problematic items from the waste stream. This appropriation is notwithstanding the maximum amount of grant assistance for a project under Minnesota Statutes, section 115A.54.

Sec. 9. BOARD OF WATER AND SOIL RESOURCES

Subdivision 1. Total Appropriation

22,700,000

To the Board of Water and Soil Resources for the purposes specified in this section.

Subd. 2. Local Government Roads Wetland Replacement Program

12,000,000

To acquire land or permanent easements and to restore, create, enhance, and preserve wetlands to replace those wetlands drained or filled as a result of the repair, reconstruction, replacement, or rehabilitation of existing public roads as required by Minnesota Statutes, section 103G.222, subdivision 1, paragraphs (l) and (m). Notwithstanding Minnesota Statutes, section 103G.222, subdivision 3, the board may implement the wetland replacement program consistent with section 404 of the federal Clean Water Act. The purchase price paid for acquisition of land or perpetual easement must be a fair market value as determined by the board. The board may enter into agreements with the federal government, other state agencies, political subdivisions, nonprofit organizations, fee title owners, or other qualified private entities to acquire wetland replacement credits in accordance with Minnesota Rules, chapter 8420. Up to five percent of this appropriation may be used for restoration and enhancement.

Subd. 3. Reinvest in Minnesota (RIM) Reserve Program**10,700,000**

To acquire conservation easements from landowners to preserve, restore, create, and enhance wetlands and associated uplands of prairie and grasslands, and to restore and enhance rivers and streams, riparian lands, and associated uplands of prairie and grasslands, in order to protect soil and water quality, support fish and wildlife habitat, reduce flood damage, and provide other public benefits. The provisions of Minnesota Statutes, section 103F.515, apply to this program. The board shall give priority to leveraging federal money by enrolling targeted new lands or enrolling environmentally sensitive lands that have expiring federal conservation agreements. The board is authorized to enter into new agreements and amend past agreements with landowners as required by Minnesota Statutes, section 103F.515, subdivision 5, to allow for restoration. Up to five percent of this appropriation may be used for restoration and enhancement.

Sec. 10. AGRICULTURE**\$ 384,000**

To the commissioner of administration to design, construct, and equip the renovation and repair of the plant protection division's potato inspection facility located in East Grand Forks. This appropriation may also be used to design and complete hazardous materials abatement.

Sec. 11. MINNESOTA ZOOLOGICAL GARDEN**Subdivision 1. Total Appropriation****\$ 18,025,000**

To the Minnesota Zoological Board for the purposes specified in this section.

Subd. 2. Asset Preservation**16,800,000**

For capital asset preservation improvements and betterments to infrastructure and exhibits at the Minnesota Zoo, to be spent in accordance with Minnesota Statutes, section 16B.307. Notwithstanding the specified uses of money under Minnesota Statutes, section 16B.307, this appropriation may be used to replace buildings that are in poor condition, outdated, and no longer support the work of the Minnesota

For a grant to the city of Rice Lake to acquire land for and predesign, design, construct, furnish, and equip extensions of clean water, sanitary sewer, storm sewer, and utilities, including a lift station, in the city of Rice Lake.

Subd. 23. South Haven; Drinking Water Improvements

3,500,000

For a grant to the city of South Haven to design, engineer, construct, and equip improvements and upgrades to the city's clean drinking water system, including the replacement of water mains, service lines, meters, and improvements to lift stations and main lift station access road.

Subd. 24. St. Michael; Wastewater Treatment System Improvements

5,000,000

For a grant to the city of St. Michael to design and construct wastewater infrastructure system improvements.

Sec. 24. MINNESOTA HOUSING FINANCE AGENCY

Subdivision 1. Total Appropriation

\$ 44,868,000

To the Minnesota Housing Finance Agency for the purposes specified in this section.

Subd. 2. Rehabilitation to Preserve Public Housing

41,868,000

For transfer to the housing development fund to finance the costs of rehabilitation to preserve public housing under Minnesota Statutes, section 462A.202, subdivision 3a. For purposes of this section, "public housing" means housing for low-income persons and households financed by the federal government and publicly owned. Priority may be given to proposals that maximize nonstate resources to finance the capital costs and requests that prioritize health, safety, and energy improvements. The priority in Minnesota Statutes, section 462A.202, subdivision 3a, for projects to increase the supply of affordable housing and the restrictions of Minnesota Statutes, section 462A.202, subdivision 7, do not apply to this appropriation.

Subd. 3. Greater Minnesota Housing Infrastructure 3,000,000

For transfer to the housing development fund for the greater Minnesota housing infrastructure grant program under Laws 2023, chapter 37, article 2, section 7.

Sec. 25. MINNESOTA HISTORICAL SOCIETY

Subdivision 1. Total Appropriation \$ 6,025,000

To the Minnesota Historical Society for the purposes specified in this section.

Subd. 2. Historic Sites Asset Preservation 5,000,000

For capital improvements and betterments at state historic sites, buildings, landscaping at historic buildings, exhibits, markers, and monuments, to be spent in accordance with Minnesota Statutes, section 16B.307. The society shall determine project priorities as appropriate based on need.

Subd. 3. County and Local Preservation Grants 1,000,000

For grants to county and local jurisdictions as matching money for historic preservation projects of a capital nature, as provided in Minnesota Statutes, section 138.0525.

Subd. 4. Lower Sioux Agency Historic Site Bond Defeasance 25,000

From the general fund to the commissioner of management and budget, in contemplation of a future transfer of land and facilities at the Lower Sioux Agency Historic Site to the Lower Sioux Community, to prepay and defease any outstanding state general obligation bonds used for improvements and betterments at Lower Sioux Agency Historic Site and other associated financing costs. This amount may be deposited, invested, and applied to accomplish the purposes of this section as provided in Minnesota Statutes, section 475.67, subdivisions 5 to 10 and 13. Upon the prepayment and defeasance of all associated debt on the real property and improvements, all conditions set forth in Minnesota Statutes, section 16A.695, subdivision 3, shall be deemed to have been satisfied and the real property and improvements shall

no longer constitute state bond financed property under Minnesota Statutes, section 16A.695.

Sec. 26. **BOND SALE EXPENSES** \$ 1,564,000

To the commissioner of management and budget from the bond proceeds fund for bond sale expenses under Minnesota Statutes, section 16A.641, subdivision 8.

Sec. 27. **BOND SALE AUTHORIZATION.**

Subdivision 1. **Bond proceeds fund.** To provide the money appropriated in this act from the bond proceeds fund, the commissioner of management and budget shall sell and issue bonds of the state in an amount up to \$1,298,235,000 in the manner, upon the terms, and with the effect prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota Constitution, article XI, sections 4 to 7.

Subd. 2. **Transportation fund.** To provide the money appropriated in this act from the bond proceeds account in the state transportation fund, the commissioner of management and budget shall sell and issue bonds of the state in an amount up to \$219,214,000 in the manner, upon the terms, and with the effect prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota Constitution, article XI, sections 4 to 7.

Sec. 28. **CANCELLATIONS; BOND SALE AUTHORIZATION REDUCTIONS.**

(a) The amounts of the general obligation bond proceeds appropriations listed in the cancellation report submitted to the legislature in 2023, pursuant to Minnesota Statutes, section 16A.642, are canceled on the effective date of this section, with the exception of appropriations and related bond sale authorizations that are extended in article 3. The corresponding bond sale authorizations are reduced by the same amounts. If an appropriation in this section is canceled more than once, the cancellation must be given effect only once.

(b) The unobligated amount remaining from the appropriation in Laws 2020, Fifth Special Session chapter 3, article 1, section 12, subdivision 3, is canceled. The bond sale authorization in Laws 2020, Fifth Special Session chapter 3, article 1, section 26, subdivision 1, is reduced by the same amount.

Sec. 29. **BOND SALE SCHEDULE.**

The commissioner of management and budget shall schedule the sale of state general obligation bonds so that, during the biennium ending June 30, 2025, no more than \$1,179,727,000 will need to be transferred from the general fund to the state bond fund to pay principal and interest due and to become due on outstanding state general obligation bonds. During the biennium, before each sale of state general obligation bonds, the commissioner of management and budget shall calculate the amount of debt service payments needed on bonds previously issued and shall estimate the amount of debt service payments that will be needed on the bonds scheduled to be sold. The commissioner shall adjust the amount of bonds scheduled to be sold so as to remain within the limit set by this section. The amount needed to make the debt service payments is appropriated from the general fund as provided in Minnesota Statutes, section 16A.641.

Sec. 30. **EFFECTIVE DATE.**

This article is effective the day following final enactment.

ARTICLE 2

GENERAL FUND APPROPRIATIONS

Section 1. CAPITAL IMPROVEMENT APPROPRIATIONS.

(a) The sums shown in the column under "Appropriations" are appropriated from the general fund in fiscal year 2024 to the state agencies or officials indicated, to be spent for public purposes. These are onetime appropriations. Money appropriated in this act is available until the project is completed or abandoned, subject to Minnesota Statutes, section 16A.642.

(b) For any project funded in whole or in part by this act, workers on the project must be paid at least the prevailing wage rate as defined in Minnesota Statutes, section 177.42, subdivision 6, and the project is subject to the requirements and enforcement provisions in Minnesota Statutes, sections 177.27, 177.30, 177.32, and 177.41 to 177.45. For the purposes of this act, "project" means demolition, erection, construction, remodeling, or repairing of a public building, facility, or other public work financed in whole or part by state funds. Project also includes demolition, erection, construction, remodeling, or repairing of a building, facility, or public work when the acquisition of property, predesign, design, or demolition is financed in whole or in part by state funds.

(c) Money appropriated in this act: (1) is available for a grant after the commissioner of management and budget determines that an amount sufficient to complete the project as described in this act has been committed to the project, as required by Minnesota Statutes, section 16A.502; and (2) may be used to pay state agency staff costs that are attributed directly to the capital program or project for capitalizable staff costs.

(d) The sustainable building guidelines under Minnesota Statutes, section 16B.325, are mandatory for all new buildings and major renovations owned or to be owned by the state, state agencies, Minnesota State Colleges and Universities, and the University of Minnesota that are funded with an appropriation in this act.

(e) Recipients of grants from money appropriated in this article must demonstrate to the commissioner of the agency making the grant that the recipient has the ability and a plan to fund the program intended for the facility. This paragraph does not apply to state agencies.

Sec. 2. MINNESOTA STATE COLLEGES AND UNIVERSITIES

\$ 1,347,000

To the board of trustees of the Minnesota State Colleges and Universities to design the renovation of space for Career and Technical Education programs at the Heintz Center at Rochester Community and Technical College.

Sec. 3. NATURAL RESOURCES.

Subdivision 1. Total Appropriation

\$ 36,204,000

To the commissioner of natural resources for the purposes specified in this section.

Subd. 2. Acquisition and Betterment of Public Lands 2,500,000

(a) For the betterment of public lands and other improvements of a capital nature. The commissioner shall determine project priorities as appropriate under Minnesota Statutes, section 86A.12. Reforestation shall be conducted in accordance with Minnesota Statutes, section 89.002, subdivision 2.

(b) For acquisition of public lands for the purposes described in Minnesota Statutes, section 86A.12, subdivision 2. The commissioner shall determine project priorities as appropriate under Minnesota Statutes, section 86A.12.

Subd. 3. Blufflands State Trail 4,000,000

For acquisition of land and construction of, as well as other costs associated with, the extension of a segment of the Blufflands trail system under Minnesota Statutes, section 85.015, subdivision 7, from Harmony to the Iowa border, including a connection to Niagara Cave in Fillmore County.

Subd. 4. Crosslake; National Loon Center 2,500,000

For a grant to the city of Crosslake for site preparation and to predesign, design, construct, furnish, and equip a new building and adjacent outdoor public space improvements, including surface lot parking areas, in the city of Crosslake to house a national loon center, to provide visitor, education, and exhibit facilities for the general public.

Subd. 5. Forest Lake; Flood Hazard Mitigation 5,700,000

For a grant to the city of Forest Lake to acquire property and design capital improvements for stormwater management, flood control, climate preparedness, and parks to achieve flood management and water quality goals and protect surrounding and downstream communities.

Subd. 6. Gaylord; Lake Titlow Dam 500,000

For a grant under Minnesota Statutes, sections 103G.511 to 103G.515, to the city of Gaylord for replacement of the Lake Titlow Dam.

Subd. 7. Kasson; Flood Hazard Mitigation 5,000,000

For a grant to the city of Kasson to acquire property and easements, design, engineer, obtain permits for, construct, furnish, and equip a stormwater impoundment infrastructure and to design, engineer, construct, furnish, and equip the replacement and renovation of sanitary sewer and stormwater infrastructure and systems and a water main, and restore roadways in a portion of the city of Kasson.

Subd. 8. Otter Tail County; Glacial Edge Trail 939,000

For a grant to Otter Tail County to predesign, design, and construct the Maplewood State Park segment of the Glacial Edge Regional Trail.

Subd. 9. Lake Shamineau Improvement District; High Water Mitigation 3,000,000

For a grant under Minnesota Statutes, section 103F.161, to the Lake Shamineau Lake Improvement District to construct publicly owned capital improvements necessary to prevent or alleviate flooding outlined in the Lake Shamineau High Water Mitigation Project.

Subd. 10. Scott County; Merriam Junction Trail and Riverbank Stabilization 4,000,000

For a grant to Scott County to predesign, design, construct, furnish, and equip the Merriam Junction riverbank stabilization project. The project will:

(1) stabilize the Minnesota River riverbank along the former UP Rail Line from the city of Carver to Merriam Junction in Scott County to reduce erosion and protect the adjacent Minnesota State Trail and planned regional trail alignment; and

(2) stabilize the Minnesota River riverbank to protect historic Native American cultural resources, public property, and natural resources, and improve water quality of the impaired river segment.

Subd. 11. Rochester; Willow Creek Trail 1,750,000

For a grant to the city of Rochester to predesign, design, engineer, construct, furnish, and equip a paved

trail to extend the Rochester Trail network approximately 2.5 miles from 28th Street SE to Gamehaven Regional Park and the future extension of the Bluestem Trail to Stewartville. This project includes a trail crossing under U.S. Highway 52, property/easement acquisition, trail rehabilitation, creek crossing, trail construction, installation of trail wayfinding and rest areas, and a trailhead located at Gamehaven Regional Park. In addition, expenditures made by the city before enactment of this subdivision related to predesign, design, and engineering are included in the nonstate contribution to the project.

Subd. 12. Roseau; Flood Hazard Mitigation

1,915,000

For a grant to the city of Roseau to design, engineer, and construct an upgraded storm sewer system in a portion of the city of Roseau.

Subd. 13. Sartell; Flood Hazard Mitigation

2,500,000

For a grant to the city of Sartell for flood hazard mitigation projects, which may include the design and construction of an open channel ditch and high capacity box culvert, replacement of other existing culverts, an outlet to Baker's Lake, and the completion of additional capital improvements necessary for flood hazard mitigation within the North Central Watab Watershed.

Subd. 14. Sauk River Watershed District; Gravity Outlet Conveyance System

1,400,000

For a grant to the Sauk River Watershed District to design, construct, and equip a gravity outlet conveyance system, including an upstream control structure at the outlet location, to direct water from Long Lake in Birchdale Township in Todd County to Sauk Lake in Todd County to mitigate issues caused by high water levels in Long Lake.

Subd. 15. Scott County; Public Water Access

500,000

For the rehabilitation and upgrading of public water access facilities in Scott County under Minnesota Statutes, section 97A.141, subdivision 3. Priority shall be given to launch ramp modifications required to address changing water surface elevations, accessibility, stormwater management, and facility

improvements necessary to accommodate current recreational boating equipment.

Sec. 4. **POLLUTION CONTROL AGENCY** **\$** **2,100,000**

To the Pollution Control Agency for a grant to Dodge County to construct, furnish, and equip a solid waste transfer station building at Dodge County's existing facility in Mantorville Township.

Sec. 5. **BOARD OF WATER AND SOIL RESOURCES** **\$** **2,000,000**

To the Board of Water and Soil Resources for a grant to the city of Beardsley to remove and replace or to repair a portion of drain line in the gravity pipe system designed to remove excess water from Dry Lake and prevent flooding. The city must undertake this project in coordination with the Upper Minnesota River Watershed District.

Sec. 6. **PUBLIC SAFETY** **\$** **7,170,000**

To the commissioner of public safety for a grant to the city of Lakeville to design, construct, furnish, and equip the renovation of an existing building for a new regional public safety training center in Lakeville to provide training facilities for first responders serving the south portion of the Twin Cities metropolitan area and adjacent cities and counties. The facility will include physical and virtual training areas, tactical training rooms, a firing range, classrooms, and meeting areas.

Sec. 7. **TRANSPORTATION.**

Subdivision 1. **Total Appropriation** **\$** **69,215,000**

To the commissioner of transportation for the purposes specified in this section.

Subd. 2. **U.S. Highway 14 and Olmsted CSAH 44** **5,000,000**

To conduct environmental analysis, predesign, design, engineer, acquire right-of-way for, construct, furnish, and equip an interchange at marked U.S. Highway 14 and County State-Aid Highway 44, including a flyover at 7th Street NW, in Olmsted County, and associated

infrastructure and road work to accommodate the interchange.

Subd. 3. Anoka County; Trunk Highway 65

25,000,000

For one or more grants to the city of Blaine, Anoka County, or both for the predesign, right-of-way acquisition, design, engineering, and construction of intersection improvements along Trunk Highway 65 at 99th Avenue Northeast, 105th Avenue Northeast, Anoka County State-Aid Highway 12 (109th Avenue Northeast), and 117th Avenue Northeast and the associated frontage roads, backage roads, connecting local streets, and utility infrastructure improvements, if necessary or required for the construction.

Subd. 4. Baytown Township; Civil Air Patrol

150,000

For a grant to the town of Baytown to construct, renovate, and equip a hangar for the Civil Air Patrol at the Lake Elmo Airport.

Subd. 5. Carver County; CSAH 18

6,240,000

For one or more grants to the cities of Victoria, Chaska, or Chanhassen or Carver County, or any combination of these entities, for property or permanent easement acquisition, predesign, and design of construction of improvements to Carver County State-Aid Highway 18, known as West 82nd Street, from Bavaria Road to marked Trunk Highway 41. This project includes cross streets, off-street trails, a bridge over a ravine and trail, and utility relocations, installations, and connections.

Subd. 6. Chisago County; U.S. Highway 8

8,000,000

(a) For a grant to Chisago County to acquire property, design, construct, and engineer the reconstruction of marked U.S. Highway 8 from Karmel Avenue in Chisago City to Interstate 35. This reconstruction may include expanding segments of U.S. Highway 8 to four lanes, constructing or reconstructing frontage roads and backage roads, and realigning local roads to consolidate, remove, and relocate access onto and off of U.S. Highway 8.

(b) Amounts planned by the Department of Transportation for the resurfacing of U.S. Highway 8, as reflected in the department's Metro District 10-Year

Capital Highway Investment Plan 2020-2029, shall instead be applied to the reconstruction of U.S. Highway 8 to supplement appropriations for that purpose from any fund in this section.

Subd. 7. Dundas; Trail Segments

370,000

For a grant to the city of Dundas for predesign, design, and construction of three trail segment connections, with ADA-compliant features. The trail segments would be located on the south side of County Road 1 between Schilling Drive and Trunk Highway 3; on the south side of County Road 1 between Trunk Highway 3 and North Stafford Road; and on the East side of Trunk Highway 3 between County Road 1 and the terminus of the existing trail.

Subd. 8. Forest Lake; Road Improvements

4,500,000

For a grant to the city of Forest Lake for improvements to Eureka Avenue from State Highway 97 to County Highway 32. Improvements include predesign; design; construction; replacement or repair and installation of water, sewer, and storm sewer utilities; street reconstruction, including improvements on roads adjacent to the project locations; and other improvements or upgrades related to street work.

Subd. 9. Greenfield; Road Improvements

3,000,000

For a grant to the city of Greenfield to design, engineer, construct, and reconstruct Greenfield Road as a paved road from U.S. Highway 55 to County State-Aid Highway 10 (Woodland Trail), and for associated stormwater improvements.

Subd. 10. Murray County; CSAH 13 Improvements

4,200,000

For one or more grants to Murray County for preliminary design, design, right-of-way acquisition, and construction of a flood mitigation and road-widening project to include shared-use paths on County State-Aid Highway 13 between marked U.S. Highway 59 and the end of County State-Aid Highway 13 on Keely Island near Lake Shetek. This project includes constructing shared-use paths, raising dikes, and relocating water main and sanitary sewer infrastructure as necessary.

Subd. 11. Ottertail; Tyler Wohlers Memorial Trail 55,000

For a grant to the city of Ottertail for the Tyler Wohlers Memorial Trail along state Trunk Highway 78 from Bay View Road to the Pelican Bay public water access.

Subd. 12. Sherburne County; U.S. Highway 169 Interchange 9,700,000

For a grant to Sherburne County for property acquisition, engineering, and construction for the local road portions of an interchange at marked U.S. Highway 169 and Sherburne County State-Aid Highway 4 in the city of Zimmerman.

Subd. 13. Thief River Falls; Airport 3,000,000

For a grant to the Thief River Falls Regional Airport Authority. This appropriation is in addition to the appropriation for the same purpose in Laws 2020, Fifth Special Session chapter 3, section 16, subdivision 27.

Sec. 8. CORRECTIONS \$ 10,000,000

To the commissioner of corrections for a grant to Carlton County to construct, furnish, and equip a new regional female offender and judicial center within the Carlton County Justice Center.

Sec. 9. EMPLOYMENT AND ECONOMIC DEVELOPMENT.

Subdivision 1. Total Appropriation \$ 26,210,000

To the commissioner of employment and economic development for the purposes specified in this section.

Subd. 2. Aitkin County; Health and Human Services Building 2,000,000

For a grant to Aitkin County for the construction of the renovation and expansion of the Aitkin County Health and Human Services building, including the replacement of heating and cooling systems; renovating and repurposing existing spaces to provide secure interview spaces, Americans with Disabilities Act accessible restrooms, meeting spaces, and convertible work areas; renovation of the lobby; and providing

increased security measures, including adding badge access, panic buttons, and clear escape routes.

Subd. 3. Chaska; City Square West

5,425,000

For a grant to the city of Chaska to acquire property for the city of Chaska plaza and paseo areas, acquire property for the city of Chaska Public Parking, acquire property for the city of Chaska Mercado and Arts Consortium Space, and to construct the city of Chaska's plaza, paseo areas, Mercado and Arts Consortium Space and Public Parking of the city Square West redevelopment project.

Subd. 4. Fergus Falls; Riverfront Corridor

4,000,000

For a grant to the city of Fergus Falls for Phase 2, Part 2 improvements as part of the city's Riverfront Corridor Project. This appropriation includes money for acquisition of approximately 11.68 acres of land, and for the design, engineering, and construction of the river buffer trail system, including accessible public parking and other public amenities. This appropriation also includes money to design, engineer, and construct two rail crossings, one at Broadway Avenue and one at St. Andrews Street, to serve as access points to the river buffer parcel and provide safe motor vehicle and pedestrian crossing.

Subd. 5. Forest Lake; Veterans Memorial

250,000

For a grant to the Forest Lake Veterans Memorial Committee to construct a memorial to veterans of the United States armed forces at Lakeside Memorial Park.

Subd. 6. Parkers Prairie; Veterans Memorial Park

50,000

For a grant to the city of Parkers Prairie to design, construct, and equip site improvements and infrastructure for a veterans memorial park along marked Trunk Highway 29.

Subd. 7. Scandia; Water Tower Barn Arts and Heritage Center

2,200,000

For a grant to the city of Scandia to predesign, design, construct, furnish, and equip the Scandia Water Tower Barn Arts and Heritage Center in the city of Scandia.

This appropriation is for the reconstruction and rehabilitation of the historic Scandia water tower barn for reuse as a regional arts and heritage center, along with construction of an amphitheater and site improvements. This facility will be located adjacent to the Gammelgarden Museum and will complement the telling of the important story of the state's original Swedish immigrant community. The water tower barn is the state's only remaining water tower barn tank house and is eligible for listing on the National Register of Historic Places for its unique engineering significance and the role that tank house facilities played in the evolution from the agrarian to the early 20th century mercantile economy.

Subd. 8. St. Louis County; Mining Exhibit

385,000

For a grant to St. Louis County to design and construct a new permanent exhibit on mining at the St. Louis County Heritage and Arts Center, also known as the Depot, in the city of Duluth.

Subd. 9. Rochester; Children's Museum

200,000

For a grant to the Rochester Children's Museum to increase access and engagement for diverse audiences through museum programs and exhibits that promote Minnesota arts, culture, and history.

Subd. 10. Stillwater; Riverfront Park

6,000,000

For a grant to the city of Stillwater to predesign, design, construct, furnish, and equip improvements to downtown, St. Croix riverfront parks, and public spaces in the city of Stillwater. This appropriation is for an Americans with Disabilities Act-accessible, nonmotorized public boat launch and fishing pier; restoration of hardwood and prairie grass exploration areas, community gathering and picnic spaces, and connections to Browns Creek State Trail at Lumberjack Landing; rehabilitation of the Lowell Park gazebo to reconstruct failing foundation and restore historic features; development of the Chestnut Street Plaza for pedestrian and event area uses connecting to the regional trail system; archaeological enhancements, historic features interpretation, fishing pier, picnic area, surface parking, and boat launch facility at Bridgeview Park; rehabilitation of the Moritz Bergstein Shoddy

Mill and Warehouse, listed on the National Register of Historic Places, for visitors and hospitality use; and public river access, public docking, and trail connections to the Stillwater Commercial Historic District, listed on the National Register of Historic Places, and regional trails from a transient dock.

Subd. 11. Washington County Heritage Center 700,000

For a grant to the Washington County Historical Society, for capital improvements at the Washington County Heritage Center in the city of Stillwater to allow for proper storage of historical artifacts. This appropriation includes money for facility remodeling, replacement of the HVAC system, roof replacement, exterior facility improvements, and the purchase and installation of appropriate storage containers for historical artifacts.

Subd. 12. Winona; Mississippi River Trail 5,000,000

For a grant to the city of Winona for final design, engineering, and construction of a bridge and bridge approaches connecting to Chestnut Street at one end and Carimona Street at the other end as part of the multipurpose nonmotorized Riverfront Trail from Levee Park to Lions Park.

Sec. 10. PUBLIC FACILITIES AUTHORITY

Subdivision 1. Total Appropriation \$ 61,779,000

To the Public Facilities Authority for the purposes specified in this section.

Subd. 2. Belview; Water Treatment Facility 1,750,000

For a grant to the city of Belview to predesign, design, construct, and equip the replacement of aging and failing municipal drinking water infrastructure.

Subd. 3. Cologne; Wastewater Treatment Facility 1,060,000

For a grant to the city of Cologne to design, permit, engineer, construct, and equip a new municipal wastewater treatment facility and related infrastructure.

Subd. 4. Corcoran; Drinking Water Infrastructure **10,000,000**

For a grant to the city of Corcoran to construct and equip drinking water improvements to serve the municipal service area of the city. This appropriation includes money for a well, a water treatment facility, a booster station, and a water storage facility.

Subd. 5. Elysian; Water Treatment Plant **3,500,000**

For a grant to the city of Elysian to construct, furnish, and equip a water treatment plant to treat drinking water for radium, manganese, and iron bacteria. This appropriation includes money for associated public infrastructure to transport water from wells 2 and 3 to the water treatment plant.

Sec. 30. Laws 2020, Fifth Special Session chapter 3, article 1, section 22, subdivision 33, as amended by Laws 2021, First Special Session chapter 9, section 42, is amended to read:

Subd. 33. **Vernon Center; Water Infrastructure Improvements** 7,984,000

For a grant to the city of Vernon Center to predesign, design, construct, furnish, and equip ~~water and wastewater treatment facilities,~~ water distribution, sanitary sewer, and storm water collection systems, and related local road improvements. Notwithstanding Minnesota Statutes, section 16A.642, the bond sale

authorization and appropriation of bond proceeds for this project are available until December 31, 2026.

Sec. 31. Laws 2020, Fifth Special Session chapter 3, article 3, section 2, subdivision 2, is amended to read:

Subd. 2. **Hmong American Farmers Association** 2,000,000

(a) For a grant to the Hmong American Farmers Association to purchase approximately 155 acres in Dakota County that the association has leased since 2014, including buildings and improvements on the property.

(b) Upon completion of the purchase of the 155 acres in Dakota County, any unspent portion of this appropriation remaining, after written notice to the commissioner of management and budget, is available to purchase additional farmland. Notwithstanding Minnesota Statutes, section 16A.642, this appropriation is available until December 31, 2026.

(c) Notwithstanding any law to the contrary, a municipality, county, or the state shall not take or condemn land purchased pursuant to this subdivision without the express consent of the property owner.

Sec. 32. **CONVEYANCE AUTHORIZED.**

Subdivision 1. **Conveyance authorized.** (a) Notwithstanding Minnesota Statutes, sections 16A.695, 16B.281 to 16B.287, 92.45, 94.09, and 94.10, any state law, administrative rule, or commissioner's order to the contrary, and the appropriation of state general obligation bond proceeds in Laws 2002, chapter 393, article 11, section 5, subdivision 6, and Laws 2005, chapter 20, article 1, section 7, subdivision 24, to the commissioner of natural resources, the parcels described in subdivision 2 may be conveyed for no consideration to the city of Two Harbors for outdoor recreation facilities. The commissioner may convey the parcels described in subdivision 2 subject to the state's reservation of an access easement if the commissioner determines that reservation of an access easement is necessary or beneficial for access to any state-owned or state-administered property. Notwithstanding any provision of this section to the contrary, the real property shall continue to be considered state bond-financed property after the conveyance of the real property to the city of Two Harbors and until all the requirements are satisfied for the real property to no longer be considered state bond-financed property. The city of Two Harbors must operate the state bond-financed property in compliance with Minnesota Statutes, section 16A.695, and all applicable state and federal laws, and in a manner that will not cause the interest on the state general obligation bonds to be subject to federal income taxation for any reason.

(b) The conveyance shall be in a form approved by the attorney general. The attorney general may make changes to the legal description to correct errors and ensure accuracy.

(c) The commissioner of natural resources has determined that the parcels are no longer needed for any state purpose and that the state's interests would best be served if the parcels were conveyed to the city of Two Harbors.

Subd. 2. Parcels. The two parcels of property conveyed in subdivision 1 are as follows:

(1) that part of Government Lot 1, Section 1, Township 52 North, Range 11 West of the Fourth Principal Meridian, Lake County, Minnesota, lying southerly and easterly of the following described lines: commencing at the center east 1/16 corner; thence along the North-South 1/16 line on an assumed bearing of North 00 degrees 46 minutes 07 seconds East 144.23 feet; thence North 67 degrees 30 minutes 43 seconds West 385.00 feet; thence North 22 degrees 29 minutes 17 seconds East 24.00 feet; thence South 67 degrees 30 minutes 43 seconds East 385.00 feet; thence easterly a distance of 232.90 feet along a tangential curve concave to the North having a radius of 611.85 feet and central angle of 21 degrees 48 minutes 36 seconds; thence South 89 degrees 19 minutes 19 seconds East 1,015.67 feet; thence South 00 degrees 40 minutes 41 seconds West 35.00 feet; thence South 89 degrees 19 minutes 19 seconds East 73.08 feet to the east line of said Government Lot 1 and the point of beginning of said line; thence North 89 degrees 19 minutes 19 seconds West 877.08 feet; thence North 00 degrees 40 minutes 41 seconds East 11.00 feet; thence North 89 degrees 19 minutes 19 seconds West 28.86 feet; thence South 00 degrees 51 minutes 25 seconds West 19.82 feet to a 3/4-inch by 24-inch rebar marked "MN DNR LS 16098" (DNR monument); thence continuing South 00 degrees 51 minutes 25 seconds West 484.06 feet to a DNR monument; thence continuing South 00 degrees 51 minutes 25 seconds West 78 feet, more or less to the shore of Lake Superior and there terminating; containing 14.5 acres, more or less (parcel identification number 23-7600-01415); and

(2) that part of Government Lot 3, Section 6, Township 52 North, Range 10 West of the Fourth Principal Meridian, described as follows: commencing at the West Quarter corner of said Section 6 (northwest corner of said Government Lot 3); thence North 88 degrees 43 minutes 09 seconds East along the north line of said Government Lot 3 a distance of 485.19 feet; thence South 00 degrees 20 minutes 34 seconds East a distance of 16 feet, more or less, to the south line of the northerly 16 feet of said Government Lot 3, being the point of beginning of the parcel described herein; thence continuing South 00 degrees 20 minutes 34 seconds East a distance of 584 feet, more or less, to a line lying within 600 feet and South of the North boundary of said Government Lot 3; thence westerly, along said line, to the west line of said Government Lot 3; thence northerly, along the west line of the said Government Lot 3 to the south line of the northerly 16 feet of said Government Lot 3; thence easterly along the south line of the northerly 16 feet of said Government Lot 3 to the point of beginning; except minerals (parcel identification number 23-7600-06605).

Sec. 33. RIVER PLACE ARTS, CULTURE, AND EVENT CENTER; SALES TAX EXEMPTION FOR CONSTRUCTION MATERIALS.

Subdivision 1. **Exemption; refund.** (a) Materials and supplies used in and equipment incorporated into the construction, reconstruction, upgrade, expansion, or remodeling of the River Place Arts, Culture, and Event Center in the city of Warroad, are exempt from sales and use tax imposed under Minnesota Statutes, chapter 297A, if materials, supplies, and equipment are purchased after May 31, 2023, and before January 1, 2026.

(b) The tax must be imposed and collected as if the rate under Minnesota Statutes, section 297A.62, subdivision 1, applied and then refunded in the same manner provided for projects under Minnesota Statutes, section 297A.75, subdivision 2, clause (7). Refunds for eligible purchases must not be issued until after June 30, 2023.

Subd. 2. **Appropriation.** \$500,000 is appropriated in fiscal year 2024 from the general fund to the commissioner of revenue to pay the refunds under subdivision 1, on a first come, first served basis. This appropriation is available until June 30, 2027.

EFFECTIVE DATE. This section is effective the day following final enactment and applies to sales and purchases made after May 30, 2023, and before January 1, 2026.

Sec. 34. **REVISOR INSTRUCTION.**

The revisor of statutes shall codify Laws 2023, chapter 37, article 2, section 7, in Minnesota Statutes, chapter 462A.

Sec. 35. **EFFECTIVE DATE.**

Except as otherwise specified, this article is effective the day following final enactment.
