Sections marked (N) were first enacted at the 2025 Regular Session or the 2025 First Special Session. Those sections will be included in full in the 2025 Minnesota Statutes Supplement.

Sections marked (A) or (R) are existing sections of Minnesota Statutes.

Chapter references to "1Sp" designate laws passed at the 2025 First Special Session.
