

CHAPTER 285—H. F. No. 732

An act relating to intoxicating liquor; repealing Minnesota Statutes 1961, Section 340.41.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **[340.411] Liquor licenses; commodities sold by licenses.** The governing body of any municipality issuing exclusive on-sale or combination on-sale and off-sale intoxicating liquor licenses may permit such licensees to sell food, cigars, cigarettes, all forms of tobacco, nonintoxicating malt beverages and soft drinks.

Sec. 2. Minnesota Statutes 1961, Section 340.41, is hereby repealed.

CHAPTER 286—H. F. No. 81

An act relating to eggs; authorizing the agriculture department to supervise, regulate, and make rules and regulations relative to egg cleaning; amending Minnesota Statutes 1961, Section 29.27.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 29.27, is amended to read:

29.27. **Eggs; cleaning; rules.** The department is hereby vested with the power and authority to supervise, regulate, and, in the manner provided by law make reasonable rules and regulations relative to grading, candling, *cleaning*, breaking, purchasing, and selling of eggs and egg products for purpose of preserving and protecting the public health. In addition hereto, it is the express purpose herein that inasmuch as the breaking of eggs for re-sale is a matter of state concern, the surroundings in which such product is handled should be maintained in a sanitary condition, and, therefore, the department may establish, in the manner provided by law, reasonable rules and regulations relative to the inspection of all establishments wherein the business of breaking eggs for re-sale is maintained, and when the sanitary conditions of any such establishment are such that the product is rendered, or is likely to be rendered, *unclean, unsound, unhealthful, unwholesome, or otherwise unfit* for human consumption, it shall have authority to revoke such

license to break eggs for re-sale until such time as the department is satisfied that the establishment is maintained in a sanitary condition. The department shall have the right, from time to time, to adopt different rules and regulations in the same manner as herein set forth.

CHAPTER 287—H. F. No. 127

An act relating to the counties of Dakota and Scott; authorizing the levy and expenditure of funds for certain library purposes; amending Laws 1961, Chapter 352, Section 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1961, Chapter 352, Section 1, is amended to read:

Section 1. **Library tax levy, Scott and Dakota counties.** The county boards of Dakota and Scott counties may levy, in addition to the library operating fund, a tax of not more than one mill, over the area in the respective counties served by the county library system for the acquisition and maintenance of library buildings, *library operation, and library services.*

The levy of such tax shall not cause the amount of other taxes levied, or to be levied by the respective counties, which are subject to any limitation, to be reduced in any amount whatsoever.

Sec. 2. *Section 1 shall be effective upon its approval by the county boards of both Dakota and Scott counties and upon compliance with Minnesota Statutes 1961, Section 645.021.*
