

## CHAPTER 538—S. F. No. 1680

[Not Coded]

*An act relating to St. Louis county; providing for salaries and compensation of certain officials.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **St. Louis county; officials' compensation.** Notwithstanding any other provision of law to the contrary, in St. Louis county the following county officials shall receive annual salaries to be paid in the same manner as is now established in said county: County attorney, \$14,500; county superintendent of schools, \$14,500; county auditor, \$12,500; sheriff, \$13,000; county treasurer, \$11,500; clerk of district court, \$10,000; register of deeds, \$10,000; and county coroner, \$6,250; to be full compensation for each of said officials for all duties performed by said officers under the laws of this state, and said officials shall be reimbursed for traveling and other expenses in connection with said duties as are now permitted by law.

Sec. 2. This act shall become effective upon approval by the board of county commissioners of the county of St. Louis and upon compliance with Minnesota Statutes, Section 645.021.

## CHAPTER 539—S. F. No. 1691

*An act relating to the municipal court of Hennepin county; employment of certain deputy clerks.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **[488A.035] Municipal court of Hennepin county; deputy clerks; date of employment.** All persons previously employed as clerks of a municipal court in the county of Hennepin but outside the city of Minneapolis, who on March 1, 1965, were employed as deputy clerks of the municipal court of Hennepin county pursuant to Laws 1963, Chapter 877, Section 48, shall be considered for salary purposes to have commenced their employment on the date they commenced their employment as clerk of a municipal court outside the city of Minneapolis.

Sec. 2. The provisions of section 1 are retroactive to January 1, 1965.

CHAPTER 540—S. F. No. 1777

*An act relating to the West Saint Paul firemen's relief association; establishing the contributions of the members and the city of West Saint Paul; authorizing the payment of disability pensions; and widows and childrens pensions.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **West St. Paul, city of; firemen's relief.** It shall be the duty of the city treasurer of West Saint Paul to deduct each month, from the monthly pay of each member of the West Saint Paul firemen's relief association, a sum equal to five percent of the basic monthly pay of a first grade fireman, and pay the same to the treasurer of the West Saint Paul firemen's relief association for the credit to the special fund of said association.

Sec. 2. The city shall annually contribute and pay to the treasurer of the West Saint Paul firemen's relief association, for credit to the special fund of said association, a sum equal to nine percent of the basic annual salary of a first grade fireman for each full-time member of the association who is employed full-time in the fire department of the city of West Saint Paul, during the entire year.

Sec. 3. The West Saint Paul firemen's relief association may pay monthly a disability pension, in an amount not exceeding 40 percent of a first grade fireman's monthly salary in the city of West Saint Paul, to disabled members of said association.

Sec. 4. The West Saint Paul firemen's relief association may pay a widow's and children's pension in an amount not to exceed the following: To a widow, a monthly sum not exceeding 30 percent of a first grade fireman's monthly salary, and for children of a deceased member of the association, an amount not exceeding five percent per child per month of a first grade fireman's monthly salary. And provided further, in no event, shall the widow and chil-
