An act authorizing the sale of the tuberculosis sanatorium operated by Chippewa, Lac qui Parle, Renville, and Yellow Medicine counties.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Chippewa county, Lac qui Parle, Renville, and Yellow Medicine counties; tuberculosis sanatorium. Notwithstanding the provisions of any other law to the contrary, the counties of Chippewa, Lac qui Parle, Renville, and Yellow Medicine may sell the real and personal property of the tuberculosis sanatorium operated by them at Granite Falls in the manner provided in Minnesota Statutes, Section 376.54, except that the sale may be made with or without bids and without the consent of the commissioner of public welfare.
- Sec. 2. This act is effective when approved by the boards of county commissioners of all of the following counties: Chippewa, Lac qui Parle, Renville, and Yellow Medicine, and upon compliance with Minnesota Statutes, Section 645.021.
