An act relating to the board of police commissioners in the city of West Saint Paul; superseding inconsistent acts.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. West St. Paul, city of; police department. The administration and control of the West Saint Paul police department shall be as provided for in chapter 6 of the West Saint Paul city charter. All laws inconsistent with the provisions of this section are superseded to the extent of the inconsistency.

Sec. 2. This act takes effect when approved by the governing body of the city of West Saint Paul and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 458-H. F. No. 2393

[Not Coded]

An act relating to the city of West St. Paul; authorizing the city council to issue bonds for highway purposes.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. West St. Paul, city of; highway bonds; council authorized to issue bonds. Subdivision 1. The council of the city of West St. Paul in Dakota county may by resolution authorize, issue and sell bonds of the city in an amount not exceeding \$900,000 to provide funds for the establishment, location, construction, reconstruction, and improvement of trunk highway numbered 52 on Robert street in the city by the state highway department. The proceeds of the bonds may be transferred to the state commissioner of highways for use on the project as provided in the agreement required by subdivision 2.

The bonds shall not be issued unless prior thereto Subd. 2. the city has entered into a contract with the commissioner of highways in which the commissioner agrees that the project will be commenced within six months after the date thereof and completed within two years. Any such contract may provide for repayment by the commissioner of highways to the city of West St. Paul of the principal amount of such advance extended to the commissioner by the city, without interest, in not over 30 annual installments. The commissioner of highways is hereby authorized on behalf of the state of Minnesota to execute such contract for repayment of the principal amount of such advance, without interest to the city of West St. Paul out of the trunk highway fund. Such contract may include all other terms and conditions which the parties may deem necessary to comply with all other provisions of law relating to cooperative agreements between the commissioner of highways and municipalities.

Subd. 3. Such contract shall authorize the commissioner of highways to use funds advanced by the city on any trunk highway project in the state, when such advanced funds are not immediately
