

exclude, expel or excuse from school privileges any person entitled to admission as a student to the schools of such district. When a person has been excluded, expelled or excused by a school board, such action of the board shall be reported to the commissioner of education within 30 days.

CHAPTER 381—S. F. No. 725

An act relating to aeronautical accidents; providing for the examination of and reports concerning certain accident victims for the presence of alcohol, drugs and carbon monoxide in blood; amending Minnesota Statutes 1967, Section 360.015, by adding a subdivision.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Section 360.015, is amended by adding a subdivision to read:

Subd. 11a. Aeronautics; accidents; blood tests of accident victims; coroner to report death. Every coroner or other official performing like functions shall report in writing to the department of aeronautics the death of any person within his jurisdiction as a result of an accident involving an aircraft. Such report shall be made within five days after such death. In case an aircraft's pilot in command or his co-pilot are killed in an aeronautical accident, and if such death occurs within four hours after said accident, then and in such cases the coroner or other official performing like function shall examine the body and shall make such tests as are necessary to determine the presence and percentage concentration of alcohol, drugs and carbon monoxide, if feasible, in the blood of the victim. This information shall be included in a report submitted to the department of aeronautics and shall be tabulated on an annual basis by the department. This information transmitted to the department may be used only for statistical purposes by the department which do not reveal the identity of the deceased.

The provisions hereof shall not be construed to limit the authority otherwise conferred by law on the coroner.

CHAPTER 382—S. F. No. 1305

An act authorizing the commissioner of taxation under certain circumstances to convey certain lands in St. Louis county under the tax forfeiture law.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Conveyance of state land; St. Louis county.** In St. Louis county are certain lands described as follows, to wit:

Lots 1 and 2, Section 33, Township 71 North, Range 20 West of the Fourth Principal Meridian.

Part of Lot 1, Section 14, Township 61 North of Range 13 West of the Fourth Principal Meridian and more particularly described as follows: Beginning at a point on the north line of said Lot 1, 1909.5 feet west of the corner common to Sections 11, 12, 13, and 14, Township 61, Range 13, thence west 707.7 feet along the north line of Lot 1 of said Section 14 to the shoreline of Bear Island Lake; thence south 18°09' east 99.6 feet; thence south 05°20' east 126.5 feet, thence south 31°47' east 76.6 feet; thence south 69°10' east 53.6 feet; thence south 86°47' east 92.1 feet; thence north 62°49' east 78.1 feet; thence north 43°50' east 83.3 feet; thence north 82°08' east 94.2 feet; thence south 87°30' east 27.5 feet; thence north 61°32' east 143.7 feet; thence south 26°28' east, 26.9 feet; thence north 38°20' east 153.0 feet; thence north 01°56' east 38.5 feet to the point of beginning. The above described land contains 3.40 acres more or less.
