CHAPTER 386—S.F.No.2477
[Coded]

An act adding a new route to the trunk highway system.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. There is added a new route to the trunk highway system as follows:

[161.115] TRUNK HIGHWAY SYSTEM; ROUTE NO. 332. Beginning at a point on Koochiching County State-Aid Highway No. 102 at its intersection with Constitutional Route No. 4 and Constitutional Route No. 11, southwesterly of International Falls, thence extending in a general easterly direction generally along the present route of said State-Aid Highway No. 102 to its junction with Constitutional Route No. 11 southeasterly of International Falls, thence extending in a general northerly direction generally along the present route of County State-Aid Highway No. 114, a distance of approximately 2 1/2 miles, thence continuing in a general northerly direction to legislative Route No. 158 east of International Falls.

Sec. 2. The revisor of statutes is directed to assign a number to such route and compile the same in the next edition of the Minnesota Statutes.

Sec. 3. This act shall become effective January 1, 1976.

CHAPTER 387—S.F.No.2505

An act relating to the probate court in Hennepin and Ramsey counties; amending Minnesota Statutes, 1973 Supplement, Section 525.10; and Minnesota Statutes 1971, Section 526.18; repealing Minnesota Statutes 1971, Section 526.19.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes, 1973 Supplement, Section 525.10, is amended to read:

525.10 PROBATE COURT; HENNEPIN AND RAMSEY COUNTIES; REFEREE; APPOINTMENT; BOND. The ~~judge~~-judges of the probate court of ~~any county in this state now or hereafter having more than 350,000 inhabitants in Hennepin and Ramsey counties~~ may appoint one ~~referee~~ or more referees in probate who shall be a resident of such county and an attorney at law duly admitted in this state. He shall hold office during the pleasure of the judge appointing him. Such appointment shall be in writing and filed in such court. Before entering upon the duties of his office, he shall execute a bond to the state in the amount of \$1,000 approved by the county board and conditioned upon the faithful discharge of his duties. Such bond with the oath of the appointee shall be recorded in the office of the register of deeds. The premiums on such bond and the expenses of such recording and filing shall be paid by the county. An action may be maintained on such bond by any person aggrieved by the violation of the conditions thereof.

Sec. 2. Minnesota Statutes 1971, Section 526.18, is amended to read:

526.18 SALARIES OF JUDGES OF PROBATE IN HENNEPIN AND RAMSEY COUNTIES. The compensation of the judges of the probate court in ~~all Hennepin and Ramsey counties of this state now or hereafter having a population of 250,000 or more~~ shall be equal to the compensation now or hereafter paid to judges of the district court in such counties, which salary shall be paid in equal monthly instalments out of the county treasury of such counties upon warrants of the county auditor out of any funds of the county not otherwise appropriated.

Sec. 3. Minnesota Statutes 1971, Section 526.19, is repealed.
