

Anoka county may acquire, develop, and construct nature centers in order to provide additional recreational facilities and to promote education and research in the environmental fields; and issue and sell its general obligation bonds in an amount not exceeding \$1,000,000 for such purposes. The nature centers shall be operated by the county or in its behalf by nonprofit or public corporations upon mutually agreeable terms.

Sec. 2. Bonds issued pursuant to this act shall be issued and sold in the manner provided by Minnesota Statutes, Chapter 475, except that approval of the electors on the question is required. The county shall levy a tax, without limit as to rate or amount sufficient to pay the principal and interest on the bonds as they become due.

Sec. 3. This act shall take effect upon its approval by the board of commissioners of Anoka county and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 389—S.F.No.2641
[Coded]

An act relating to motor vehicles; use of certain equipment thereon; authorizing the use of certain equipment on motor vehicles of nonresidents of this state under certain conditions; amending Minnesota Statutes, 1973 Supplement, Section 169.72, by adding a subdivision.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes, 1973 Supplement, Section 169.72, is amended by adding a subdivision to read:

Subd. 4. MOTOR VEHICLES; STUDED OR WIRE EMBEDDED TIRES; NONRESIDENTS. Notwithstanding the provisions of subdivision 1, a person, operating a motor vehicle properly licensed and registered in another state or province of a foreign country which authorizes the use of tires with metal studs or wire embedded tires on its highways, may operate the motor vehicle with tires having metal type studs or with tires having wire embedded therein on the highways of this state while occasionally within the state, and such use while occasionally within the state is not unlawful; provided that, the metal type studs shall not exceed 5/16 of an inch in diameter inclusive of the stud casing with an average protrusion beyond the tread surface of not more than 7/64 of an inch, and the number of studs in a tire shall not exceed two percent of the total net contact area. Use of a vehicle in this state on more than 30 days in any consecutive six-month period is not occasionally. Except, a person whose regular place of employment

is within the state or who is a student at an educational institution located within the state, shall not operate a vehicle, regardless of its place of registration, upon any highway within the state if such vehicle is equipped with tires which would be unauthorized were the vehicle registered in this state.

CHAPTER 390—S.F.No.2690

An act relating to the supreme court; authorizing the court to promulgate rules of criminal procedure which supersede certain statutes; amending Minnesota Statutes 1971, Section 480.059, Subdivisions 6 and 7.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1971, Section 480.059, Subdivision 7, is amended to read:

Subd. 7. **SUPREME COURT; RULES OF CRIMINAL PROCEDURE; EFFECT UPON STATUTES.** Nothing herein contained shall be deemed to grant the supreme court power to amend or modify any statute—Present statutes relating to the pleadings, practice, procedure, and the forms thereof in criminal actions shall be effective until modified or superseded by court rule. If a rule is promulgated pursuant to this section which is in conflict with a statute, the statute shall thereafter be of no force and effect. Notwithstanding any rule, however, the following statutes remain in full force and effect:

(a) Statutes which relate to substantive criminal law, found in Minnesota Statutes, Chapters 609, 617, and 624, except for sections 609.115, 609.116, and 609.145;

(b) Statutes which relate to the rights of the accused, found in Minnesota Statutes, Sections 611.01 to 611.033, 611.11 to 611.12, and 611.30 to 611.34 and Laws 1973, Chapter 317;

(c) Statutes which relate to the prevention of crime, found in Minnesota Statutes, Chapter 625;

(d) Statutes which relate to training, investigation, apprehension, and reports, found in Minnesota Statutes, Chapter 626;

(e) Statutes which relate to privacy of communications, found in Minnesota Statutes, Chapter 626A;

(f) Statutes which relate to extradition, detainers, and arrest, found in Minnesota Statutes, Sections 629.01 to 629.404;
