**CHAPTER 111—S.F.No.871**

*An act relating to St. Louis County; providing for the donation of Mesabi nursing home to range hospital corporation, a nonprofit corporation.*

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:**

**Section 1. ST. LOUIS COUNTY; DONATION OF MESABI NURSING HOME.** The St. Louis County board is hereby authorized to donate to range hospital corporation, a nonprofit corporation, located in Buhl, Minnesota, the Mesabi home which is more particularly described as follows:

That tract of land lying and being in the city of Buhl and the county of St. Louis and state of Minnesota, described as follows:

Lots 20, 21, 22, 23, 24, 25, 26, Block Five (5), First Addition to Buhl, together with the building or buildings located thereon, now or in the future, except however, all iron ore and other minerals and mineral rights as heretofore reserved and former conveyances of record in the office of the Registrar of Titles, St. Louis County, Minnesota.

**Sec. 2.** This act shall become effective only after it is approved by a majority vote of the members of the county board of St. Louis County, and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

**CHAPTER 112—S.F.No.1038**

*An act relating to certain counties; providing for the filing of surveys with the county surveyor.*

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:**

**Section 1. [389.07] COUNTY SURVEYOR; FILING OF SURVEYS IN CERTAIN COUNTIES.** In any county in which the office of county surveyor is a full time position and the surveyor has an office in a building maintained by the county for county purposes, the county board may by ordinance adopted in accordance with section 375.51 require that any registered land surveyor who shall perform a survey of land for an individual or corporation shall file a true and correct copy

of the survey in the office of the county surveyor within 30 days after completion of the survey. The manner of filing, and all incidents thereof, shall be determined by the county surveyor. All surveys so filed shall be public records and shall be available at all reasonable times for inspection by any person.

**CHAPTER 113—S.F.No.1088**

*An act relating to natural resources; authorizing the establishment of additional state trails; amending Minnesota Statutes 1974, Section 85.015, Subdivision 13.*

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:**

Section 1. Minnesota Statutes 1974, Section 85.015, Subdivision 13, is amended to read:

**Subd. 13. NATURAL RESOURCES; STATE TRAILS; ADDITIONS. Taconite Trail—Arrowhead Region Trails, in Cook, Lake, St. Louis, Koochiching and Itasca counties.**

(a) (1) The Taconite Trail shall originate at Ely in St. Louis county and extend southwesterly to Tower in St. Louis county, thence westerly to McCarthy Beach state park in St. Louis county, thence southwesterly crossing state trunk highway number 169 at O'Brien creek between Keewatin and Nashwauk in Itasca county, thence southwesterly to Blackberry in Itasca county and there terminate :

(2) The Northshore Trail shall originate in Duluth in St. Louis county and extend northeasterly to Two Harbors in Lake county, thence northeasterly to Grand Marais in Cook county, thence northeasterly to the international boundary in the vicinity of the north shore of Lake Superior, and there terminate;

(3) The Grand Marais to International Falls Trail shall originate in Grand Marais in Cook county and extend northwesterly, outside of the Boundary Waters Canoe Area, to Ely in St. Louis county, thence southwesterly along the route of the Taconite Trail to Tower in St. Louis county, thence northwesterly through the Pelican Lake area in St. Louis county to International Falls in Koochiching county, and there terminate.

(b) ~~The trail-trails~~ shall be developed primarily for riding and hiking.
