# CHAPTER 289—S.F.No.1184

#### [Not Coded]

An act relating to Hennepin county; authorizing the county board to make appropriations from its county road and bridge fund to certain municipalities within the county for roads and streets.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. HENNEPIN COUNTY; APPROPRIATIONS FROM ROAD AND BRIDGE FUND. Notwithstanding the provisions of any law to the contrary, the county board of Hennepin county may appropriate from its road and bridge fund to any town or city within the county, such sums of money as are available and which the county board deems advisable to aid any such town or city in the construction and maintenance of roads, streets or bridges therein. The appropriations may be directly expended by the county board on roads, streets or bridges designated by the governing body of the town or city, and may be expended in accordance with Laws 1905, Chapter 164, as amended. No such town or city shall receive an appropriation hereunder exceeding 30 percent of the annual county tax levy for road and bridge purposes paid by the town or city.

Sec. 2. This act is effective upon its approval by the county board of Hennepin county, and upon compliance with Minnesota Statutes, Section 645.021.

### CHAPTER 290—S.F.No.1222

An act relating to courts; Hennepin county municipal court; providing for assignment of retired judges to hear certain causes; amending Minnesota Statutes 1974, Section 488A.021, by adding a subdivision.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1974, Section 488A.021, is amended

Subd. 9. HENNEPIN COUNTY MUNICIPAL COURT: RETIRED MUNICIPAL COURT JUDGES, ASSIGNMENTS. Upon the retirement of any judge of the municipal court of Hennepin county, he may, with his consent, be appointed and assigned, by the then chief judge upon authorization of a majority of the municipal court judges, to hear any cause properly assignable to a judge of the municipal court of Hennepin county and act thereon with full powers of such a judge. When such retired judge undertakes such service, he shall be provided at the expense of the county a courtroom or hearing room for the purpose of holding court or hearings, to be paid for by the county, and shall be paid in addition to his retirement compensation and not affecting the amount thereof, the sum of \$50 per diem for such additional service, together with travel pay in the sum of twelve cents per mile and his actual expenses incurred in such service, said payment to be made in the same manner as the payment of salaries for district judges, on certification by the presiding or senior judge of the district or by the chief judge of the supreme court of the state of Minnesota.

Sec. 2. This act is effective the day following final enactment.

# CHAPTER 291-S.F.No. 1299

An act relating to education; fluctuating school enrollments; providing for study by an advisory commission; appropriating money; repealing Laws 1974, Chapter 355, Section 68, Subdivision 4.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. EDUCATION; ADVISORY COMMISSION ON FLUCTUATING SCHOOL ENROLLMENTS. There is hereby appropriated from the general fund the sum of \$60,000 for use by the advisory commission to the legislature and the state board of education known as the advisory commission on fluctuating school enrollments, created by Laws 1974, Chapter 355, Section 68, for the purposes stated therein. This appropriation shall be available until expended or until the purposes for which it is appropriated are completed.

- Sec. 2. Laws 1974, Chapter 355, Section 68, Subdivision 4, is repealed.
