Subd. 2. An adult person may by a written instrument, the form of which is not inconsistent with the terms of the policy or contract and which is filed with and recorded by the insurance company during such person's lifetime, direct (a) an insurance company to distribute proceeds of a life insurance policy or annuity contract which are payable to a person who is a minor on the date on which payment is due to the custodian designated in such instrument for such minor; (b) that ownership of a life insurance policy or annuity contract on the life of a minor or on the life of a member of the minor's family shall vest in a custodian designated in such instrument for such minor upon the happening of a stated event.
