CHAPTER 141—H. F. No. 336

*An act relating to candling, grading, handling, and marketing of eggs; amending Minnesota Statutes 1965, Section 29.21, Subdivision 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1965, Section 29.21, Subdivision 1, is amended to read:

29.21 **Definitions.** Subdivision 1. The word "person" when used in sections 29.21 to 29.28 means any individual, firm, partnership, corporation, company, association, joint stock association, and shall include any officer, employee, agent, trustee, receiver, assignee, or other similar representative thereof, provided that neither a producer of eggs when selling shell eggs of ~~his own production produced on a farm occupied and cultivated by him~~, nor a hatchery which produces or purchases shell eggs solely for hatching shall be deemed a "person."

Sec. 2. **Effective date.** *This act is effective April 1, 1967.*

CHAPTER 142—S. F. No. 680

*An act relating to civil service in St. Louis county; amending Laws 1941, Chapter 423, Section 6, as amended.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1941, Chapter 423, Section 6, as amended by Laws of 1949, Chapter 255, Section 1, Laws 1949, Chapter 258, Section 1, Laws 1949, Chapter 309, Section 1, Laws 1951, Chapter 310, Section 1, is amended to read:

Sec. 6. **St. Louis county; classified, unclassified service.** The officers and employees of such county and of any agency, board, or commission, supported in whole or in part by taxation upon the taxable property of such county or appointed by the judges of the district or probate court for such county, are hereby divided into the unclassified and classified service. The unclassified service shall comprise:

a. All officers elected by popular vote or persons appointed to fill vacancies in such offices.

b. Judges and receivers, referees, arbiters, court reporters, jurors, notaries public, and persons appointed by a court to make or conduct any special inquiry of a judicial and temporary character.

c. Superintendent or principal administrative officer or comptroller of any separate department of county government which is now or hereafter created pursuant to law, who is directly responsible to the board of county commissioners or any other board or commission, as well as the county agricultural agents and the home demonstration agents under the control of the county extension committee.

d. Members of the teaching staff ~~and~~ , *supervisors* and principals in the employ of the superintendent of county schools.

e. Members of non-paid board, or commissioners appointed by the board of county commissioners or acting in an advisory capacity.

f. Assistant county attorneys or special investigators in the employ of the county attorney.

g. All common labor temporarily employed on an hourly basis.

h. All inmate or patient help in county institutions.

i. All physicians, dentists, registered nurses and medical laboratory technicians working under the direction of a licensed physician or dentist in any hospital or sanatorium operated by a commission or board of such county.

j. All county commissioners' clerks appointed by the county board after the passage of this act; but nothing in this act shall affect the civil service status of any person previously appointed and now holding such a position in the classified service of the county.

The classified service shall include all other positions now existing and hereinafter created in the service of the county or any board or commission, agency, or offices of such county.

Sec. 2. *This act shall become effective upon approval by the board of county commissioners of the county of St. Louis and upon compliance with Minnesota Statutes, Section 645.021.*

CHAPTER 143—S. F. No. 674

*An act relating to St. Louis county officials' compensation.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **St. Louis county; officials compensation.** Notwithstanding any other provision of law to the contrary, in St. Louis county the county board of commissioners shall set the annual salaries of the following elected officials and in an amount not less than as follows: County attorney, \$14,500; county superintendent of schools, \$14,500; county auditor, \$12,500; sheriff, \$13,000; county treasurer, \$11,500; clerk of district court, \$10,000; register of deeds, \$10,000; and county coroner, \$6,250; the same shall be full compensation for all their services except that they shall be also entitled to reimbursement for traveling and other expenses in connection with their duties. The salary of no such official shall be reduced during the term for which he was elected or appointed except that in the event a vacancy occurs, in any such office, the board may set the annual salary in an amount not less than the minimum hereinbefore provided.

Sec. 2. This act shall become effective upon approval by the board of county commissioners of the county of St. Louis and upon compliance with Minnesota Statutes, Section 645.021.
