

(b) If the assessment be not payable in instalments, no lien need be filed, and the assessment, plus interest from date of the order to August 15 of the succeeding calendar year, shall be entered on the tax lists for the year and be due and payable with and as a part of the real estate taxes for such year. When any such assessment is levied and made payable in instalments, the county auditor shall file for record in the office of the register of deeds an additional tabular statement in substance as provided in section 106.341, and all the provisions of sections 106.351, 106.371, and 106.381 relating to collection and payment shall apply thereto. Upon the filing of the tabular statement, the instalment and interest shall be due and payable and shall be entered on the tax lists and collected the same as the original lien.

(c) Whenever a contract for ditch repair has been entered into under this chapter, or such repair has been ordered to be constructed by day labor, and when the county board has ordered the assessments to be paid in instalments, the county board may issue and sell bonds, as provided by section 106.411.

(d) In the case of the repair of a state drainage system established wherein no assessment of benefits to lands was made when such system was established, the board or court shall observe the requirements of chapter 106, and appoint viewers to determine the benefits resulting from such repair and otherwise observe all requirements of this chapter in the procedure for the collection of such assessments as shall thereafter be made.

CHAPTER 194—S. F. No. 1190

[Coded]

An act relating to aeronautics; providing for the transfer of certain radio air navigation facilities from the state of Minnesota to the United States government or to a political subdivision of the state of Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **[360.023] Transfer of radio air navigation facilities.** The commissioner of aeronautics of the state of Minnesota, with the approval of the governor, is hereby granted authority to transfer and assign to the United States government or to any political subdivisions of the state of Minnesota all or any part of

such radio air navigation facilities along with shelters, repair parts, and supplies used in connection therewith, as are now or hereafter owned by the state of Minnesota, and as are also now or hereafter maintained, repaired, operated, and used by its department of aeronautics.

The commissioner of aeronautics, with the approval of the governor, is authorized to make such transfer and assignment herein upon the conditions that, and so long as, the United States government, or the political subdivision, as the case may be, will undertake the duty to, and does, maintain, repair, operate, and use such air navigation facilities within the boundaries of the state of Minnesota for the benefit of the public.

CHAPTER 195—H. F. No. 171

An act relating to county and district agricultural societies and associations; changing the name of a society to reflect a name change caused by reorganization; amending Minnesota Statutes 1961, Section 38.02, Subdivision 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 38.02, Subdivision 1, is amended to read:

38.02 Agricultural societies and associations; aid, distribution. Subdivision 1. **Schedule.** (1) All sums hereafter appropriated to aid county and district agricultural societies and associations shall be distributed to the following named agricultural societies or associations: Aitkin County Agricultural Society, Anoka County Agricultural Society, The Becker County Agricultural Society and Fair Association, Beltrami County Agricultural Association, The Benton County Agricultural Society, Big Stone County Agricultural Society, Blue Earth County Agricultural Association, Mankato Fair and Blue Earth County Agricultural Association, Brown County Agricultural Society, The Carlton County Agricultural and Industrial Association, Carver County Agricultural Society of Waconia, Cass County Agricultural Society, Chippewa County Fair Association, The Chisago County Agricultural Society, Clay County Fair and Agricultural Association of Barnesville, Clay County, Minnesota, Clearwater County Agricultural Society, Cook County Agricultural Society, Cottonwood County Agricultural Society, Crow Wing Coun-
