CHAPTER 258-S. F. No. 932

An act relating to veterans in the armed forces; amending Minnesota Statutes 1953, Sections 197.71, 197.75.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 197.71, is amended to read:

The word "soldier" as used in 197.71Definitions. sections 197.71 to 197.74, 197.76 and 197.77 means any man or woman who shall have been engaged in active service as a part of the military or naval forces of the United States in the war between the United States and Germany, Japan, Italy, and their Allies, and who was a resident of the state of Minnesota at the time he was commissioned, enlisted, inducted, appointed, or mustered into the military or naval service, and who has been or may be given an honorable or ordinary discharge from such service; provided that such service shall have been given wholly or in part between December 7, 1941, and the cessation of hostilities as declared by proper federal authority and shall have continued for not less than 90 days unless terminated sooner by disability due to service in the military or naval forces.

Sec. 2. Minnesota Statutes 1953, Section 197.75, is amended by adding a subdivision to read:

The word "soldier" as used in this section means any man or woman who shall have been engaged in active service as a part of the military or naval forces of the United States in the war between the United States and Germany, Japan, Italy, and their Allies, or the Korean Conflict, and who was a resident of the state of Minnesota at the time he was commissioned, enlisted, inducted, appointed, or mustered into the military or naval service, and who has been or may be given an honorable or ordinary discharge from such service; provided that such service in the war between the United States and Germany, Japan, Italy, and their Allies, shall have been given wholly or in part between December 7, 1941, and December 31, 1946, both dates inclusive, or in the Korean Conflict between

June 27, 1950 and January 31, 1955, and shall have continued for not less than 90 days unless terminated sooner by disability due to service in the military or naval forces.

CHAPTER 259—S. F. No. 943

An act relating to the terms of district court in the nineteenth judicial district; amending Minnesota Statutes 1953, Section 484.27.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 484.27, is amended to read:

484.27 Nineteenth judicial district. The general terms of the district court to be held each year in the several counties constituting the nineteenth judicial district of the State of Minnesota shall be held commencing on the days hereinafter set forth, as follows, to-wit:

In Chisago County on the second Tuesday in April and the second Tuesday in November;

In Kanabec County on the second Tuesday in June and the second Tuesday in December, but no petit jury shall be drawn or summoned in Kanabec County unless the court shall so direct on written order made and filed with the clerk of said court at least 20 days before the dates herein fixed for holding said court;

In Pine County on the second Tuesday in March and the second Tuesday in September;

In Washington County on the first Monday in January, the first Monday in April and the first Monday in October.

In addition to the general terms of the district court in Washington County, special terms of said court shall be held in said county on the second Monday of each month for the trial of issues of law and fact without jury, and the hearing of motions and applications.

Sec. 2. The provisions of this act shall become effective July 1, 1957.
