The commissioner of conservation of the state of Minnesota is hereby authorized to execute and deliver to the village of Baudette, Lake of the Woods county, Minnesota a deed for which no consideration need be paid conveying all right, title and interest of the state in and to the following described lands, in the county of Lake of the Woods, state of Minnesota, subject to the reservation of all minerals and mineral rights, to-wit:

Lots 1, 2 and 3, Block 4, 1st addition to Baudette.

Lots 1, 2 and 3, Block 6, 2nd addition to Baudette.

CHAPTER 44-S. F. No. 200

An act relating to drivers licenses; amending Minnesota Statutes 1957, Section 171.20.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 171.20, is amended to read:

171.20 Driver's licenses must be surrendered. The commissioner, upon suspending or revoking a license, shall require that all license certificates issued to the licensee shall be surrendered to and be retained by the department, except that at the end of a period of suspension the license certificate shall be returned to the licensee. Upon demand for surrender of a license by the commissioner, the licensee shall immediately forward the license certificates to the department. If any person fails to return to the commissioner the license as provided herein, the commissioner shall forthwith direct any peace officer to serve the order of suspension or revocation of the

drivers license on such person and direct such person to surrender said license.

Any resident or non-resident whose driver's license or right or privilege to operate a motor vehicle in this state has been suspended, revoked, or canceled, as provided in this chapter, shall not operate a motor vehicle in this state under a license, permit, or registration certificate issued by any other jurisdiction or otherwise during such suspension, or after such revocation until a new license is obtained when and as permitted under this chapter.

 - a. Any temporary license or instruction permit;
- b. The privilege of any person to drive a motor vehicle whether or not such person holds a valid license;
- c. Any non-resident's operating privilege as defined herein.
