tional duties to be performed by the register of deeds as a registered abstracter as defined in Minnesota Statutes, Section 386.61, Subdivision 2, Clause (2). After a resolution providing for such additional duties and compensation is adopted, any fees charged and collected by the register of deeds for services he renders as a registered abstracter as defined in Minnesota Statutes, Section 386.61, Subdivision 2, Clause (2), shall be paid to the county in compliance with the provisions of Minnesota Statutes, Section 386.015, Subdivision 5, and no such fees shall be retained by the register of deeds as personal compensation as therein provided.

Sec. 4. This act takes effect when approved by the county board of Koochiching county and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

An act designating and establishing the route of "Glacial Ridge Trail".

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [161.14] Highways; Glacial Ridge Trail. Subdivision 1. [Subd. 15.] The following route is named and designated the "Glacial Ridge Trail":

Beginning at the junction of Trunk Highway No. 71, at its intersection with Trunk Highway No. 12, in Willmar; thence extending north and northeasterly along Trunk Highway No. 71 to its intersection with Kandiyohi County Highway No. 90; thence extending east along said Highway No. 90 to its junction of Kandiyohi County State Aid Highway No. 9; thence extending north and northeasterly along said Highway No. 9 to its junction of Kandiyohi State Aid Highway No. 26; thence extending east along said Highway No. 26 to its junction of Kandiyohi State Aid Highway No. 8; thence extending north along said Highway No. 8 to its junction of Kandiyohi State Aid Highway No. 10, south of Green Lake; thence northerly along said Highway No. 10 to its junction of Kandiyohi State Aid Highway No. 30 in Spicer; thence extending northerly and easterly along said High-

way No. 30 to its junction with Kandiyohi County State Aid Highway No. 2; thence extending northerly on said Highway No. 2 to a highway easterly of Long Lake; thence in a general southwesterly direction on existing highways to Trunk Highway No. 9 in New London; thence extending westerly on said Highway No. 9, to its junction with Trunk Highway No. 71; thence southerly on said Highway No. 71 to Kandiyohi State Aid Highway No. 48; thence extending in a general northwesterly direction on existing highways to Trunk Highway No. 104; thence northerly on said Highway No. 104 to county road No. 84; thence in a general northwesterly direction on existing highways to Trunk Highway No. 104; thence along said Highway No. 104 in a northerly direction to Pope County State Aid Highway No. 18; thence westerly on said Highway No. 18 to Pope State Aid Highway No. 17: thence northerly on said Highway No. 17 to Glenwood; thence northerly through Glenwood on Trunk Highway No. 29 to Pope State Aid Highway No. 28; thence easterly on said Highway No. 28 to Pope State Aid Highway No. 25; thence southerly on said Highway No. 25 to Trunk Highway No. 28; thence westerly on said Highway No. 28 through Glenwood and thence follow Pope State Aid Road No. 54 and Trunk Highway No. 28 to Starbuck; thence extending in a southerly direction on Trunk Highway No. 29 to the highway marked No. 74; thence in a general easterly and southerly direction on existing highways through Monson Lake State Memorial Park; thence in a general easterly and southerly direction on existing highways to junction of Trunk Highway No. 71 with Kandiyohi County Highway No. 90, northerly of Willmar.

Subd. 2. The respective road authorities of the highways over which the route described in subdivision 1 is located shall adopt and place suitable marking signs on the highways under their jurisdiction to adequately mark the highways as "Glacial Ridge Trail".
