1 of any year, the town board shall levy an assessment against the lands of such owner or owners, which assessment shall be certified by the town board of the town of Stuntz to the county auditor as unpaid and the county auditor shall add to the real estate tax rolls of the property taxable in such town all such unpaid assessments.

Sec. 3. This act shall become effective upon its approval by a majority vote of the town board of the town of Stuntz and upon compliance with Minnesota Statutes 1961, Section 645.021.

CHAPTER 492-S. F. No. 723

An act relating to the commissioner of corrections; conferring certain powers with reference to uncompensated and voluntary services of certain persons; amending Minnesota Statutes 1961, Section 241.01.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 241.01, is amended by adding a subdivision thereto:

Subd. 6. Corrections department; uncompensated and voluntary services. To assist in the discharge of the functions of his department the commissioner of corrections shall have authority to accept uncompensated and voluntary services and to enter into contracts or agreements with private or public agencies or persons for such uncompensated and voluntary services as he may deem practicable.

CHAPTER 493-S. F. No. 733

An act relating to workmen's compensation; providing coverage for voluntary uncompensated workers in state institutions; amending Minnesota Statutes 1961, Section 176.011, Subdivision 9.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, 176.011, Subdivision 9, is amended to read:

Subd. 9. Workmen's compensation; voluntary uncompensated workers; employee. "Employee" means any person who performs service for another for hire; and includes an alien, a minor, a sheriff, deputy sheriff, constable, marshal, policeman, fireman, a county highway engineer, an executive officer of a corporation, and a peace officer while engaged in the enforcement of peace or in and about the pursuit or capture of any person charged with or suspected of crime; but does not include an official of the state, or of any county, city, town, village, borough, school district or governmental subdivision therein elected or appointed for a regular term of office or to complete the unexpired portion of any such regular term, except those heretofore specified.

Voluntary uncompensated workers, other than inmates, rendering services in state institutions under the commissioner of public welfare and state institutions under the commissioner of corrections similar to those of officers and employees of such institutions, and whose services have been accepted or contracted for by the commissioner of public welfare or the commissioner of corrections under authority of Minnesota Statutes, Section 246.36 as authorized by law, shall be employees within the meaning of this subdivision. In the event of injury or death of any such voluntary uncompensated worker, the daily wage of the worker, for the purpose of calculating compensation payable under this chapter shall be the usual going wage paid at the time of such injury or death for similar services in institutions where such services are performed by paid employees.

Voluntary uncompensated workers engaged in peace time in the civil defense program when ordered to training or other duty by the state or any political subdivision thereof, shall be employees. The daily wage of the worker for the purpose of calculating compensation payable under this chapter, shall be the usual going wage paid at the time of such injury or death for similar services where such services are performed by paid employees.

In the event it is difficult to determine the daily wage as herein provided, then the commission may determine the wage upon which the compensation is payable.
