CHAPTER 579—H. F. No. 36

An act relating to game and fish; authorizing inspection of firearms; amending Minnesota Statutes 1953, Section 97.52, Subdivision 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 97.52, Subdivision 2, is hereby amended to read:

Subd. 2. No person shall wilfully hinder, resist, or obstruct the commissioner, director, game wardens, agents or other employees of the division in the performance of their official duties, or refuse to submit any wild animals, firearms in the field or any motor vehicle, boat, aircraft or other conveyance used therein, and licenses in his possession to inspection.

CHAPTER 580—H. F. No. 50

[Coded]

An act relating to speed restrictions of motor vehicles on highways; amending Minnesota Statutes 1953, Section 169.14, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 169.14, as amended by Laws 1955, Chapter 802, is amended by adding a subdivision to read:

[Subd. 8.] Where the commissioner determines upon the basis of an engineering and traffice investigation that a particular portion of the state trunk highway system is so constructed and that the traffic using such portion of the highway system should move at a speed in excess of a certain determined minimum he shall issue his order making such determination. The order shall specify the particular portion of highway affected, the minimum speed permissible and a determination by the commissioner that the minimum speed prescribed is reasonable and necessary to the safe use of the

portion of the highway affected. Upon the issuance of such order, the commissioner shall cause such portion of highway to be appropriately posted with reasonable and adequate signs sufficient to inform the traveler of the nature of the minimum and maximum permissible speeds and the zone boundaries established by the order. Upon such posting it shall be unlawful to travel upon such portion of the highway at a speed less than the established minimum.

CHAPTER 581—H. F. No. 99

An act relating to game and fish; providing that licensee must accompany deer when transported by means other than common carrier; amending Minnesota Statutes 1953, Section 97.45, Subdivision 4.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 97.45, Subdivision 4, is amended to read:

Subd. 4. Any licensed resident may transport by common carrier to any point in the county of his residence, consigned to himself only, not more than three separate shipments of undressed birds, each of which may contain all of the birds which could lawfully be taken within the state on any single day, but not to contain more than a single day's limit of any species. Such resident may transport during any one open season and the next following two days one deer, which has been lawfully taken and possessed, and may transport the head or hide of such deer for mounting or tanning purposes to a point within or without the state, provided that all such shipments shall be accompanied by shipping coupons to be detached from the licenses; but if such deer is not transported by common carrier, the licensee must accompany such deer.

CHAPTER 582-H. F. No. 103

An act relating to game and fish; authorizing the commissioner of conservation to prescribe rules and regulations pertaining to possession and transportation of wild animals from any boundary waters of the state; amending Minnesota Statutes 1953, Section 97.48, Subdivision 3.
