Section 1. CITY OF MINNEAPOLIS AND HENNEPIN COUNTY: MUNICIPAL BUILDING COMMISSION. That from and after the first Monday in January, 1904, all of the completed portions of the Hennepin county and Minneapolis court house and city hall building, erected pursuant to chapter 395 of the Special Laws of 1887, shall be under the exclusive care of a commission of four members, styled "The Municipal Building Commission," which shall be constituted as follows: The chairman of the board of county commissioners of Hennepin county, the mayor of the city of Minneapolis, the auditor of Hennepin county a person appointed by the board of county commissioners of Hennepin county, who shall serve at its pleasure, and the treasurer a person appointed by the city council of the city of Minneapolis, who shall serve at its pleasure. The chairman of the board of county commissioners of Hennepin county shall be president of said commission, and the mayor of the city of Minneapolis, vice president thereof. The auditor of Hennepin county person appointed by the board of county commissioners of Hennepin county shall be the secretary of said commission and as such shall keep the records and accounts thereof. The treasurer comptroller treasurer of the city of Minneapolis shall be the treasurer of such commission and as such shall keep a correct account of its the receipts and expenditures of the commission. The commission shall by resolution establish regular meeting dates.

Sec. 2. This act is effective the day following its final enactment.

An act relating to redevelopment; providing for membership on regional development commissions; amending Minnesota Statutes 1976, Section 462.388, Subdivision 1.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1976, Section 462.388, Subdivision 1, is amended to read:

- 462.388 REGIONAL DEVELOPMENT COMMISSIONS; COMMISSION MEMBERSHIP. Subdivision 1. A commission shall consist of the following members:
- (1) one member from each county board of every county in the development region;
- (2) one additional county board member from each county of over 100,000 population;
- (3) the town clerk, town treasurer, or one member of a town board of supervisors from each county containing organized towns;
- Changes or additions indicated by underline deletions by strikeout

- (4) one additional member selected by the county board of any county containing no townships;
- (5) one mayor or councilman from a municipality of under 10,000 population from each county, selected by the mayors of all such municipalities in the county;
- (6) one mayor or councilman from each municipality of over 10,000 in each county;
- (7) two school board members elected by a majority of the chairmen of school boards in the development region;
  - (8) one member from each council of governments;
- (9) citizens representing public interests within the region including members of minority groups to be selected after adoption of the bylaws of the commission; and
  - (10) the chairman, who shall be selected by the commission.

An act relating to retirement; judges' survivors' benefits; option to continue.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. RETIREMENT; JUDGES; ELECTION TO CONTRIBUTE. Any judge in office on December 31, 1973 who failed to elect to continue contributions as authorized by Minnesota Statutes, Section 490.124, Subdivision 10, may elect to resume said contributions as of July 1, 1977 by giving notice to the executive director of the Minnesota state retirement system prior to July 1, 1977. The notice shall be accompanied by a remittance equal to four percent of the salary earned by the judge between January 1, 1974 and July 1, 1977 plus six percent of the amount remitted in lieu of interest.

Sec. 2. This act is effective the day following final approval.
