

CHAPTER 13.

An Act to Amend the Revised Statutes.

March 3, 1854.

Be it enacted by the Legislative Assembly of the Territory of Minnesota, That Sections two and three of Chapter 73 of the Revised Statutes, passed by the Legislative Assembly of this Territory, be and the same are hereby amended, as follows:

Fees of Clerks
of District Courts
amended.

Subdivision two of Section two be amended so as to read as follows:

SEC. 2. Entering the return of every writ, and filing such writ, fifteen cents for each folio.

Subdivision 5 of Sec. 2, be amended so as to read as follows:

Entering every other rule or order, fifteen cents for each folio.

Subdivision 11 of Sec. 2, be amended so as to read as follows:

Entering recognizance, fifty cents.

Subdivision 17 of Sec. 2, be amended so as to read as follows:

Entering satisfaction of judgment, fifteen cents for each judgment debtor.

After the words "is otherwise made," in the fourth line of subdivision 23 of Sec. 2, be amended so as to read as follows:

Ten cents for each folio.

Subdivision 25 of Sec. 2, be amended so as to read as follows:

Receiving and filing the papers of any insolvent, ten cents for each paper filed.

Subdivision 26 of Sec. 2, be amended so as to read as follows:

Copies of such papers, ten cents for each folio.

Subdivision 28 of Sec. 2, be amended so as to read as follows:

Recording credentials of ordination of ministers, and giving certificates of the same, one dollar.

Subdivision 29 of Sec. 21, be amended so as to read as follows:

Recording certificate of the solemnization of marriage fifty cents.

Subdivision 30 of Sec. 21, be amended so as to read as follows:

Entering transcript of Justice's judgment, ten cents for each folio.

Subdivision 31 of Sec. 2, be amended so as to read as follows:

Entering appeal from Justices' Court, fifty cents.

Subdivision 34 of Sec. 2, be amended so as to read as follows:

Entering appeal from Justices' Court, fifty cents.

Subdivision 34 of Sec. 2 be amended so as to read as follows:

Issuing Commission to take deposition, one dollar.

Subdivision 35, Sec. 2, be amended so as to read as follows:

Issuing venire facias, seventy-five cents.

All after the words "herein prescribed," in the fourth line of subdivision 43, Sec. 2, together with subdivision 44 and 45 of Sec. 2, be and the same are hereby repealed.

And be it further enacted: That the fees of the Clerks of District Courts for making docket entries of Judgments shall be fifteen cents for each judgment debtor.

Filing and docketing a transcript of Judgment docket from any other county, the same fees as for docketing those originally in his own county.

Fees of Clerks
of District Courts

Attendance on Court for each day of actual session to be paid from the County Treasury, five dollars.

For docketing, entering the return of, and filing execution, fifty cents.

Subdivision 3 of Sec. 3, Chap. 73, be amended so as to read as follows:

For filing the papers sent at one time from a District Court, ten cents for each paper.

Subdivision 6 of Sec. 3, be amended so as to read as follows:

Entering every rule or order, fifteen cents for each folio.

Subdivision 7 of Sec. 3, be amended so as to read as follows:

For a certified copy of every rule or order, and all papers, pleadings, and proceedings filed with him, ten cents for each folio.

Subdivision 8 of Sec. 3, be amended so as to read as follows:

Entering every decree or sentence, ten cents for each folio.

Subdivision 9, Sec. 3, be amended so as to read as follows:

Entering every judgment or order, fifteen cents for every judgment debtor; and ten cents for each folio more than two.

Subdivision 10, Sec. 3, be amended so as to read as follows:

Engrossing every remitter to be sent to a District Court, ten cents for each folio.

Subdivision 11, Sec. 3, be amended so as to read as follows:

Every certificate given on request, relative to any matter or cause, twenty-five cents.

Subdivision 12, Sec. 3, be amended so as to read as follows:

Taxing cost, fifty cents.

Subdivision 14 of Sec. 3, be amended so as to read as follows:

Taking security in cases authorized by law, fifty cents.

Subdivision 16 of Sec. 3, be amended so as to read as follows:

For searching records and files in his office, except for suitors and their attorneys, twenty cents for the records or files of each year.

Subdivision 18 of Sec. 3, be amended so as to read as follows:

Entering causes, without process, fifty cents.
