Be it enacted by the Legislative Assembly of the Territory of Minnesola, That W. H. Folsom, Patrick Fox, J. L. Taylor, W. S. Hungerford, William Kent, Nelson McCarty, John Dobney, William Colby, Orange Walker, F. W. Lammers and N. C. D. Taylor, and such other persons as may be associated with them, are hereby created a body corporate in law by the name of the St. Croix Bridge Company, for the purpose of constructing a bridge, across the St. Croix River, at a point called the Narrows or Taylor's Falls; and the Company, or their assigns, may in their corporate capacity and name, sue and be sued, plead and be impleaded, answer and defend, in any court of record in this Territory, or elsewhere, and may have a common seal and change the same at pleasure.

SEc. 2. The corporator's names in the first section of this act or such other persons as they may name, are hereby appointed commissioners to receive subscriptions to the capital stock of said company, and shall open books at such times and places as the majority of the said commissioners appoint, until the capital stock of said Company is taken.

SEC. 3. The capital stock of said Company shall be thirty-five Capital stock. hundred dollars, with power to increase the same to five thousand dollars, and be divided into shares of twenty-five dollars each, and each share shall be entitled to one vote in the election of officers, and in the business of said Company, when votes are necessary to be taken.
