CHAPTER LIX.

A Bill to amend an act granting Daniel F. Brawley the right to establish and maintain a Ferry across the Mississippi river.

SECTION 1. The ferry charter granted to Daniel F. Brawley extended.

2. Kind of boat to be kept, and under what restraints.

Increase of bond required.
 The right to alter, amend or repeal reserved.

Be it enacted by the Legislative Assembly of Minnesota Territory:

SECTION. 1. That the term of time granted to Daniel F. Brawley in Charter extended the act to which this is amendatory, for establishing and maintaing a Ferry across the Mississippi river, shall be, and the same is hereby extended for

eight additional years, to D. F. Brawley, his executors, administrators of

assigns,

Kind of bost to be kept.

SEC. 2. The said Daniel F. Brawley, his heirs, executors, administrators or assigns, from the passage of this act, till the expiration of the term of time thus limited and prescribed, shall at all times, during the navigable season, keep a safe and good boat or boats, which may be propelled by steam power, or in any other way, properly managed and in good repair and condition, sufficient for the accommodation of all persons wishing to cross at said ferry, subject to all the provisions and restraints of the act to which this is amendatory.

Increase of bond.

SEC. 3. The said Daniel F. Brawley shall within sixty days after the passage of this act, increase his bond of surety with the commissioners of Ramsey county, from one thousand dollars to two thousand dollars, conditioned as prescribed in the act to which this is amendatory.

Reserved rights.

SEC. 4. The Legislature may alter or amend this act at any time.
