

## CHAPTER CVI.

*A Bill to provide for the laying out of a Territorial Road from Stillwater to a point on Snake River.*

- SECTION 1. Names of Commissioners.  
 2. Time and place of meeting.  
 3. Expenses, how paid.  
 4. Take effect.

*Be it enacted by the Legislative Assembly of the Territory of Minnesota :*

Commissioners SECTION 1. That Mahlon Black, Isaac Staples and James H. Spencer, be, and the same are hereby appointed Commissioners to survey and locate a Territorial road from Stillwater, in Washington county, M. T., via Comfort's settlements and the big bend of Rum River to the north line of township 42, range 23.

Meeting SEC. 2. The said Commissioners or any two of them shall meet in the store of Henry Staples & Co., in the city of Stillwater on the fifteenth day of March next, and from thence shall proceed to lay out and locate said road by the most feasible and direct route as soon as possible, and shall file a profile of said road, together with a copy of the field notes in the office of the Register of Deeds of the various counties through which this road may pass.

Expenses paid SEC. 3. The expense of locating the said road shall be audited by the County Commissioners of the various counties respectively wherein the same is located, and be defrayed by the counties in proportion to the length of the road within their respective boundaries.

Take effect SEC. 4. This act shall take effect from and after its passage.

## CHAPTER CVII.

*A Bill for an act to provide for laying out a Territorial Road from the Point Douglas and St. Louis River Road to Mille Lac.*

- SECTION 1. Names of Commissioners.  
 2. Time and place of meeting.  
 3. Statement of expenses made in writing.  
 4. When to take effect.

*Be it enacted by the Legislative Assembly of the Territory of Minnesota :*

Commissioners SECTION 1. That Patten W. Davis, James Harvey, and John L. Brown, be, and the same are hereby appointed Commissioners to locate and mark

out a Territorial Road commencing at some point on the eighty first mile of the Point Douglas and St. Louis River Road, and from thence on the most practicable route to Mille Lac.

SEC. 2. That the said Commissioners shall meet on the tenth day of March next, or as soon as practicable at the house of John L. Brown, in Chisago county, and at said meeting shall fix the time when they shall commence said road; and may adjourn from time to time as may in their opinion be necessary, and in case either of the persons hereby appointed neglect or refuse to act as such commissioner, the other commissioners may supply the vacancy by the appointment of some suitable person, who shall have the same authority as the Commissioners appointed by this act.

Meeting.

SEC. 3. That a statement of the necessary expenses incurred in surveying, locating and marking out said road, shall be made in writing by said commissioners, and a copy thereof furnished to the commissioners of each county through which said road may pass, and the expense so incurred shall be paid by the counties in which the road is located, each county paying in proportion to the length of said road in said county, the amount to be paid by each county shall be designated by the statement of said commissioners. Provided, that if any portion of said road shall be within the boundaries of an unorganized county, the expense of locating such portion of the road shall be paid by the organized county to which said unorganized county may be attached for judicial purposes.

SEC. 4. This act shall take effect and be in force from and after its passage.

5. When to take effect.

SECTION 1. That John Soules, R. B. Odell, Lawrence Leonard, Robert Ellis, and John McCale of Scott County, be, and they are hereby appointed Commissioners, to lay out and mark a Territorial road from Spring Lake in Scott County, to intersect the road known as the Dodd
