File Bond	SEC. 4. That said Reuben Richmond and John L. Wilson shall within one year after this act takes effect, file or caused to be filed with the Clerk of the Board of County Commissioners of the county of Stearns a Bond with two or more sufficient sureties to be approved by said Clerk in the penal sum of five hundred dollars, conditioned that they will fulfil all the duties that are imposed upon them in the foregoing sections.	
Fine for neglect	SEC. 5. For every neglect in keeping a good and sufficient boat, or to give prompt and ready attendance, the said Reuben Richmond and John L. Wilson shall forfeit a sum not exceeding fifteen dollars, to be recovered by a civil action before any Court having jurisdiction.	
Remedy for injury	SEC. 6. Any person who shall sustain any injury by the negligence or default of said Reuben Richmond and John L. Wilson may have a remedy on the bond required in this act.	
Take effect	SEC. 7. This act shall take effect on the 1st day of July next.	
	SEC. 8. The Legislature may amend this act at any time.

CHAPTER CXX.

An Act granting to J. L. Wertz the right to establish and maintain a ferry across Root River.

- SECTION 1. Ferry Granted J. L. Wertz.
2. Keep good boat.
 3. Rates of Ferrriage.
 4. File Bond.
 5. Fine for neglect.
 6. When to take effect.

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

Ferry } SECTION 1. That J. L. Wertz, his heirs, executors, administrators and assigns, shall have the privilege and right for the period of fifteen years of keeping and maintaining a ferry across Root River, on section 28,

township 104, Range 40 west of the fifth principal meridian and no other Ferry shall be established within one mile of said section twenty-eight either above or below the same.

Sec. 2. That said J. L. Wertz shall at all times keep boats in good repair sufficient for the accommodation of all persons wishing to cross at said ferry, and shall give prompt and ready attendance on passengers and teams on all occasions; but persons wishing to cross at said ferry after eight o'clock at night may be charged double the rates as hereinafter prescribed. Keep good boat

Sec. 3. The rates charged for crossing said ferry shall not exceed the following: Rates

For each foot passenger,	- - - - -	5 cents.
For each horse, mare or mule, with or without rider,	- - - - -	15 "
For each ox or cow,	- - - - -	10 "
For each two horse, two ox, or two mule team loaded or unloaded, with driver,	- - - - -	25 "
For each single horse carriage,	- - - - -	20 "
For each additional horse, mule ox or cow,	- - - - -	10 "
For each swine or sheep,	- - - - -	5 "

All freight of lumber, merchandise or other articles not in teams at the rate of ten cents per barrel, 50 cents per 1000 feet of lumber and five cents per hundred pounds for all other articles.

Sec. 4. The said J. L. Wertz shall within twelve months after the passage of this act file or cause to be filed with the County Commissioners of Houston county a bond for the benefit of said county with two or more sureties to be approved by said Commissioners, in the penal sum of five hundred dollars, conditioned that he will fulfil all the duties that are imposed upon him in the foregoing sections. File Bond

Sec. 5. For every neglect in keeping good and sufficient boats or failure to give prompt and due attendance the said J. L. Wertz shall forfeit and pay a sum not exceeding ten dollars to be secured by any action before any court having competent jurisdiction. Fine for neglect

Sec. 2. This act to take effect from and after its passage. Take effect
