SEC. 4. Any neglect on the part of the said Board to apply the said money as is hereinbefore specified, shall be deemed a misdemeanor in office.

CHAPTER XXXIV.

An Act to Organize the County of Farribault, and to Establish the County Seat of said County.

SECTION 1. That the county of Farribault be and the same is hereby declared to be an organized county, and invested with all the rights privileges and immunities to which all organized counties in this Territory are entitled by law.

SEC. 2. That "Blue Earth City," situated between the forks of Blue Earth river, as laid out and named by James B. Wakefield and others, be and the same is hereby declared to be the temporary county seat of said county, and the County Commissioners to be appointed as hereafter provi-

ded, shall have full power to locate the county buildings thereon,

SEC. 3. That the Governor shall appoint and commission three suitable persons, the same being qualified voters of said county, to be a Board of County Commissioners for said county, with full power and authority to perform all acts and discharge all duties devolving upon the Board of County Commissioners of any organized county in this Territory. And that he shall also appoint and commission one Sheriff, a Register of Deeds and two Justices of the Peace for said county, who shall hold their offices respectively until their successors shall have been duly elected and qualified.
