inserting in the twelfth line after the words, "in the Territory of Minnesota," the following words, to wit: and, also, with the privilege of a branch Railroad starting from Hokah and running by the most direct and feasible route to some point in the village of Brownsville, in the county of

Houston, in the Territory of Minnesota.

SEC. 2. That section sixteen of the act of which this is amendatory, be amended to read as follows, to wit: This act is hereby declared to be May be amended. a public act, and may be amended by any subsequent Legislative Assembly, in any manner, not destroying or impairing the vested rights of said corporation.

CHAPTER LVI.

An Act to authorize School District Number Five, in the City of Saint Anthony, Ramsey County, to Levy a Tax and Obtain Money for the Purchase of Ground and the Erection of Buildings for School Purposes.

Section 1. Provides for raising money.

Interest on loan.
 Treasurer to give bonds.

4. When Trustees may act.

Be it enacted by the Legislative Assembly of the Territory of Minnesota: SECTION 1. That the Trustees of School District number five in the Lovy Taxes.

City of St. Anthony, Ramsey County, be and they are hereby authorized to levy a tax on all the taxable property within said School District to obtain a sum of money not to exceed twelve thousand dollars, for the purchase of ground and the erection of Buildings tor the school purposes of said District.

Borrow Money.

SEO. 2. That said Trustees be authorized to borrow money in behalf of said School District, not to exceed twelve thousand dollars and at a rate of interest not to exceed twelve per cent. per annum, for the use and purposes expressed in Sec. 1 of this act.

Bonds.

Szc. 3. That the Treasurer of said District number five, shall be, and he is hereby required to give bonds with sufficient sureties, to the Treasurer of said District, in the sum of twenty-five thousand dollars, or double the probable amount of funds that may pass into his hands as Treasurer of said District, conditioned for the faithful keeping, disbursing and for said

funds.

First meeting.

SEC. 4. The authority conferred upon the Trustees of said School District number five, by Sections one and two of this act shall not be exercised until it shall be decided in a meeting of the legally qualified voters of said District, that tax shall be levied or a loan or loans made; and due notice by publication in the paper of said City of St. Anthony shall be given of such meeting at least two weeks before the meeting, which said notice shall expressly show what action is contemplated by said meeting, whether to levy tax or to create loans. And any action without such notice, under this act, shall be void.
