#### Be it enacted by the Legislative Assembly of the Territory of Minnesola :

SECTION 1. The several Boards of County Commissioners of the several counties in this Territory, may at any regular or special meetings of Boundes said Boards, make such provision, and allow such bounties for the destruction of Wolves in their respective counties as they may deem reasonable ; the said bounty to be paid out of the treasury of the county wherein said Wolf or Wolves may be taken and killed.

SEC. 2. That upon the proper oath being made before the Clerk of the Board of County Commissioners, or Justice of the Peace of the proper county respectively, the said Clerk or Justice of the Peace shall issue their certificates to the persons entitled thereto, which certificate, when issued, shall Certificates. be received by the collector of the proper county, for county tax.

SEC. 3. It shall be the duty of the several Clerks of the Boards of County Commissioners to keep a true and perfect record of the amount of certificates issued as a premium for wolf scalps, to whom, and at what Record. date, and lay the same before their respective Boards, at each regular meeting thereof.

SEC. 4. This act shall be in force from and after its passage.

# CHAPTER LXVII.

An Act to Extend the Corporate Limits of the Town of Henderson.

SECTION 1. Limits extended.

Corporation authorized to enter land. 2.

3. Limits not to extend East of the Minnesota River.

When to take effect, 4.

Be it enacted by the Legislative Assembly of the Territory of Minnesota :

SECTION 1. That the corporate limits of the Town of Henderson in Sibley County, shall be extended over the north-east quarter of section eleven (11), and the south-east quarter of section two (2), and lot number five (5), in section twelve (12), in town 112 north, range 26 west of the fifth principal meridian.

SEC. 2. That the corporate authorities of said town are hereby authorized to enter any land within the limits of said town as herein extended. under the provisions of the law of Congress relative to the entry of town sites, and dispose of the same in the manner provided by the act to incorporate the Town of Henderson.

SEC. 3. That the corporate limits of said Town of Henderson shall not hereafter extend East of the Minnesota River.

SEC. 4. This act to be in force from and after its passage.
