## CHAPTER LXXII.

An Act to amend an act entitled "an act to incorporate the Pittsbury and Minnesota Mining Company," passed by the Legislative Assembly of Minnesota Territory, and approved the 3d day of March, A.D., 1855.

SECTION 1. County of Carver declared organized.
2. When to take effect,

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

SECTION 1. That section eight of an act entitled "An Act to incorporate the Pittsburgh and Minnesota Mining Company," passed by the Legislative Assembly of the Territory of Minnesota, and approved the 3d day of March, A.D., 1855, be so amended and the same is hereby so amended as to read as follows:

SEC. 8. That the county of Carver be and the same is hereby declared to be an organized county, with all and singular the rights, privileges and immunities to which all organized counties are entitled, and the Carver County. County Seat thereof is hereby established and located at Chaska, in said county, until the legal voters of said county shall otherwise elect. And at the next general election it shall be competent for the legal voters of said county to vote by ballot, which shall be headed "For County Seat," and the name of the place voted for thereon written or printed for either of the following named places, to wit: Chaska, Carver, and San Francisco, and either of the above named places receiving the higher or greater number of such votes, shall thereafter be the County Seat of said county.

Sec. 2. This act shall be in force from and after its passage.

## CHAPTER LXXIV.

An Act to amend an act entitled an act providing for the survey of Logs and Lumber in Minnesota Territory, approved March 1st, 1854.

> Section 1. What shall constitute the reveral districts. When to take effect,

Be it enacted by the Legislative Assembly of the Territory of Minnesota: Section 1. That section two of said act be and the same is hereby

Districts

SEC. 2. The St. Croix River and its tributaries shall constitute the first District; the Mississippi river and its tributaries between the mouth of the St. Croix river and Elk river (excepting the St. Croix) shall constitute the second District. The Mississippi river and its tributaries below the mouth of the St. Croix river shall constitute the third District. The Mississippi river and its tributaries above the mouth of Elk river shall constitute the fourth District.

The Surveyor General of the fourth District shall keep his office at Little Falls.
