

*Names.* Cornell are hereby appointed Commissioners to locate and mark out a Territorial Road commencing on the Iowa Line near the Red Cedar and run thence northwardly to the village of Austin in Mower County ; thence up the valley of the said Cedar, on the most practicable route to Owatonia, and from thence to Faribault ; and a continuation of the same to the Dodd Road, near Lakeville.

*Meeting.* SEC. 2. That the said Commissioners meet at the house of Orlando Wilders, on the Iowa Line, on the first Monday in May next, at 10 o'clock, A. M., or as soon as practicable thereafter : Provided, however, that in the absence of any one of the Commissioners appointed by this act, the others may have power to supply said vacancy by appointing another Commissioner to supply said vacancy, or may, in case a majority of them meet, proceed to discharge their duties ; and it shall be discretionary with a majority of said Commissioners to adjourn from time to time as they may deem proper ; and said Commissioners, when assembled, shall proceed to lay out and mark said Road.

*Expenses.* SEC. 3. That all necessary expense incurred for laying out and establishing said Road, shall be paid by the county or counties through which said road may pass, according to the distance said road may pass through each county, to be determined by the Commissioners.

## CHAPTER LXXXII.

*An Act which to Provide for the laying out a Territorial Road from Cannon Falls to the Iowa Line.*

- SECTION 1. Names of Commissioners.  
2. First meeting.  
3. Plat of Road.  
4. May employ surveyor.  
5. Commissioner to appoint substitute.  
6. When to take effect.

*Be it enacted by the Legislative Assembly of the Territory of Minnesota :*

*Commissioners.* SECTION 1. That James M. Sumner, Peter Mantor and Samuel Hull, be and the same are hereby appointed Commissioners to locate a Territorial Road from Arnoldsville on the Iowa Line, to Forestville, Spring Valley, Elkhorn, Pleasant Valley, Mantorville to Cannon Falls.

SEC. 2. That said Commissioners shall meet at the town of Mantorville on the first Monday in April, A. D., 1856, or as soon thereafter as practica-

ble, and proceed to lay out and mark said road by the most direct and feasible route. The expense of laying out the same be paid by the different counties through which said road may pass. The Commissioners shall decide the amount each county shall pay of such expenses, and notify the Commissioners of each county of the same.

Sec. 3. It is hereby made the duty of the said Commissioners to make out a full plat of the said road and file a copy of the same in the office of the County Commissioners or Register of Deeds of the different counties which said road may pass through. Duty of Commissioners.

Sec. 4. That the Commissioners are hereby empowered to employ the services of a surveyor and other persons necessary for the locating the said road. Employ surveyors.

Sec. 5. In case of inability on the part of either of the above named Commissioners to act in the location of said road, he shall have the power to appoint a substitute, and it shall be his duty to notify the other Commissioners; Provided, That if at the first meeting stipulated above, either of the Commissioners shall fail to appear, in person, then it shall be the duty of the other Commissioner or Commissioners to appoint suitable persons to fill such vacancy. Appoint substitutes.

Sec. 6. This act to take effect and be in force from and after its passage. To be in force.

*Be it enacted by the Legislative Assembly of the Territory of Minnesota:*
