

CHAPTER XC.

A Bill for an act to legalize a Road from Crow Wing to Mille Lac and from Mille Lac to the head of Lake Superior in Minnesota Territory.

- SECTION 1. Routes of Roads legalized.
2. File, profile and field notes.
3. Take effect.

Be it enacted by the Legislative Assembly of the Territory of Minnesota:

Routes legalized SECTION 1. That the route explored out from Crow Wing to Mille Lac, by Anson Northrop in the month of January, 1856, be and the same is hereby adopted as a Territorial Road. And also that the route explored out by Brott and Wilson in the months of October and November, 1855, from Mille Lac to the head of Lake Superior be and the same is hereby adopted as a Territorial Road. And also that the route explored out by William Stingis from Little Falls to the head of Mille Lac be and the same is hereby adopted as a Territorial Road. And also that the route explored out by Brott and Wilson from St. Cloud to the head of Mille Lac be and the same is hereby adopted as a Territorial Road.

File profile SEC. 2. That the above named persons who have explored the said several roads, be authorized to file with the Registers of Deeds of the several counties through which said roads may pass a profile and the field notes of the survey of the said roads, and that said profile and field notes, when filed as aforesaid, are hereby declared to be a legal record of said roads.

Take effect SEC. 3. This act shall take effect on and after its passage.

CHAPTER XCI.

An Act to locate a Territorial Road from Fort Ripley to Fort Ridgley

- SECTION 1. Names of Commissioners.
2. Meeting of Commissioners and how substitutes may be appointed.
3. Return of map.

Commissioners *Be it enacted by the Legislative Assembly of the Territory of Minnesota:*

SECTION 1. That Anson Northrop, Allen Morrison and Hyacinth St. Cyr, be, and are hereby appointed Commissioners to locate a road from

Fort Ripley, in the county of Todd; by the way of Long Prairie, by the most feasible route to Fort Ridgley.

SEC. 2. That the aforesaid Commissioners shall meet at the ^{Time of meeting} Store, at Fort Ripley, on the first day of June, 1856, and if either of the above named Commissioners shall neglect to attend, it shall be in the power of the one or the two who may be present, to appoint a substitute or substitutes.

SEC. 3. That a map of the survey of said road shall be returned to the ^{Deposits copy a} office of Secretary of the Territory, on or before the first day of Octo- ^{map} ber, 1856.

CHAPTER XCII.

An Act to provide for laying out a Territorial Road from St. Cloud to Fort Ripley.

- SECTION 1. Names of Commissioners.
2. Expenses, by whom paid.
3. Take effect.

Be it enacted by the Legislative Assembly of the Territory of Minnesota.

SECTION 1. That David Gilman, H. G. Fillmore, John L. Young, and ^{Names of Com-} John W. Tenvoord are hereby appointed Commissioners to locate and es- ^{missioners} tablish a Territorial road from St. Cloud to Fort Ripley on the most practicable route.

SEC. 2. That said counties through which said road may pass shall pay ^{Expenses paid} the expenses for locating the same.

SEC. 3. This act shall take effect, and be in force from and after its ^{Take effect} passage.
