Seventh. With these facts before us, your Memorialists feel it to be their duty to urge most earnestly upon your consideration the grant hereby prayed for, as by it sufficient would be saved in three years, from moneys now necessarily expended by the government, to reimburse the trensury for the donation in this Memorial prayed for. By it, trade and commerce between distant and estranged portions of our Territory would be enlivened and protected. By it, vast regions of the public domain now sparsely inhabited would be made to teem with an active and thrifty population, adding to the national wealth, and hastening the sale and improvement of the public lands.

Eighth. Where so much good can be obtained by legislative action at no marrides or cost to the nation, your Memorialists are confident in their

belief that what is herein asked will be cheerfully bestowed.

Ninth. Your Memorialists, therefore, respectfully pray that a conation of the lands overflowed by the rise of the Minnesota river, be made to the Territory of Minnesota to aid in the improvement of the navigation fo said river.

ritory of Minnesota.

Second. From Decorah in the State of lows, to La Orosse in Wisconsip, by way of Belleville, Caledonia and Hokah.

For new mail

Third. From Lansing in the State of Iowa, to Brownsville, Minnesota Territory, by way of Portland Prairie and Caledonia.
