CHAPTER XVIL

An Act to lay out and establish a State Road from Fort Ridgley, by way of Mankato, Albert Lea, and Shell Rock City, to the North Line of the State of Iowa, at Otranto.

SECTION 1. Poard of Commissioners.

- Meeting of Hoard—power to appoint subtsitute.
 Per diem for Commissioners, &c.
 Expenses paid by the several counties.

- 5. Statement of expenses to be made in writing. File plat of said road with Register of Deeds.
- Take effect.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That E. P. Skinner, Anthony D. McSweeny and Commissioners Jacob Brust, be and the same are hereby appointed Commissioners to locate and mark out a State Road, commencing at Fort Ridgley and running from thence by way of Mankato, Albert Les, and Shell Rock City, to the north line of the State of Iowa at Otranto.

That said Commissioners shall meet at the office Meeting_ap. of the Register of Deeds of Brown County, on the first Mon-Sec. 2. day of March, A. D. 1858, or as soon thereafter as practicable and proceed to lay ont and mark said road, and in case either of the above named Commissioners neglect or refuse to act as such Commissioner, the other Commissioners may supply the vacancy by the appointment of some suitable person who shall have the same authority as is by this Act conferred upon either of said Commissioners above named.

SEC. 3. That said Commissioners shall be allowed the sum of three dollars per day for the time necessarily occupied in

the location of said road, and they are hereby empowered to employ one Surveyor at five dollars per day, and two Chainmen and one Axeman at two dollars per day.

That each county through which said road shall SEC. 4. pass, shall pay the expenses incurred in the location of the Expenses same, in proportion to the length of said road in each county, respectively.

That a statement of said expenses so incurred SEC. 5. shall be made in writing by said Commissioners, which statement shall designate the amount of the same to be so paid by each of the said counties, a copy of which statement shall ment of exbe furnished by said Commissioners to the Board of County pense Commissioners of each of the said Counties, and the orders of the said Road Commissioners upon the Treasurers of each of said Counties respectively for the amounts so designated shall be by said Treasurers paid out of the moneys in the Treasuries of the said Counties respectively.

SEC. 6. That it is hereby made the duty of said Commis-File plat of sioners to make out a full plat of said road, and file a copy road of the same in the office of the Register of Deeds of the several Counties through which said road shall pass.

SEC. 7. This Act shall take effect and be in force from and Take effect after its passage.
