

CHAPTER CLXXII.

An Act to locate a State Road from Red Wing, in Goodhue county, to Albert Lea, in Freeborn county.

- SECTION 1.** Appointment of Commissioners to lay out Road.
 2. When the Commissioners shall meet.
 3. Draft of the location of the road to be deposited with County Commissioners.
 4. Expenses to be paid by counties through which the road passes.
 5. Per diem of Commissioners.
 6. Authority for Commissioners to employ substitutes.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That Geo. A. Watrous, D. S. Bentley and Alpheus Hall, be and the same are hereby appointed and constituted Commissioners for the purpose of locating and laying out a State Road, commencing at the town of Red Wing in the County of Goodhue ; from thence by way of Zumbrota, Concord, Ashland, Oak Glen, Geneva, and Bancroft, to Albert Lea, in the County of Freeborn.

SEC. 2. That said Commissioners shall meet at Red Wing on or before the first Monday in September, A. D. 1858, and proceed to discharge the duties imposed upon them by the provisions of this Act.

SEC. 3. That said Commissioners shall make out a fair and correct draft of the location of said road, and deposit, or cause to be deposited, in the office of the Clerk of the Board of County Commissioners of the counties through which said road may pass, a true and correct copy of said copy of said draft.

SEC. 4. That each of the several counties through which said road shall pass shall pay the expenses incurred in the location of the same in proportion to the length of said road in each county respectively.

SEC. 5. That said Commissioners shall be allowed the sum of three dollars per day for the time necessarily occupied in the location of said road ; and they are hereby authorized and empowered to employ one Surveyor at three dollars per day, two chain-men and one axe-man at two dollars per day, for the purpose of aiding in the location of said road.

SEC. 6. That each or either of said Commissioners are hereby empowered to employ a substitute to act in said Commissioner's stead in the event that either of them shall be unable to enter upon the duties of this Act either from sickness or otherwise.

CHAPTER CLXXIII.

An Act to locate a State Road from Marion to Ashland.

- SECTION 1. Commissioners appointed to locate a State Road from Marion to Ashland.
2. First meeting of Commissioners.
 3. Copy of plat of Road to be deposited with Register of Deeds.
 4. Power of Commissioners to appoint substitutes.
 5. Per diem of Commissioners.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That W. P. Gibson, ——— Little, and Jas. L. Commissioners Hodges, be, and the same are hereby appointed Commission-^{appointed}ers to lay out, mark and survey a State Road from Marion in Olmsted county, to Ashland, in Dodge county.

Sec. 2. The said Commissioners or their substitutes duly ^{Meeting of com} authorized, shall meet at Marion on the second Monday of ^{missioners} September, A. D. 1858, or as soon thereafter as may be practicable, and proceed to survey, mark and lay out said road by the nearest and most feasible route. The expense of laying out and surveying said road shall be paid by the counties through which said road may pass. The Commissioners shall decide the proportion and amount of such expense to be paid by said counties through which said road may pass, and notify the Clerk of the Board of Supervisors of each of said counties of the same.

Sec. 3. The above named Commissioners shall cause to
