## CHAPTER CLXXXV.

### *An Act to authorize the County of Brown to collect Toll at the Big Cottonwood Bridge.*

- SECTION 1. Bridge across Big Cottonwood Creek, declared a toll bridge.  
 2. Tolls collected to be paid into Treasury of Brown County.  
 3. Rates of Toll for crossing.  
 4. Rates of Toll to be posted upon the Bridge.  
 5. Authority to collect Toll for ten years, then bridge to be free.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That the bridge now being constructed by the said County of Brown, over the Big Cottonwood River, near its mouth, in said county, shall be, when completed, a toll bridge, under the supervision and control of the County Board of Supervisors for said county; and the said Board of Supervisors, and their successors in office, shall have full authority to collect toll at the said bridge of all persons crossing the same, and shall employ a toll-gatherer for that purpose, which toll-gatherer shall be required to give to the said Board a good and sufficient bond, to be approved by them, for the faithful accounting, paying over of all moneys received for toll at said bridge, and he shall have such compensation, as may be by said Board prescribed.

SEC. 2. That all moneys collected as toll under the provisions of this Act, shall be paid into the Treasury of said County of Brown for the use thereof.

Rates of toll for  
crossing

SEC. 3. The rates of toll for crossing said bridge shall not exceed the following, viz: For each foot passenger, five cents; for each horse, mare or mule with rider, ten cents; for each one-horse carriage, fifteen cents; for each two-horse, two-ox or two-mulo team, loaded or unloaded, with driver, twenty-five cents; for each additional horse, mule, ox or cow, one cent per head; for each swine, or sheep, or goat, one-half cent per head.

SEC. 4. It shall be the duty of said Board of Supervisors to post upon said bridge, in a conspicuous place, the rates of toll authorized to be taken thereon.

Authority to  
collect toll

SEC. 5. The authority of the County of Brown to collect toll at the said bridge, shall be for the term of ten years, after which time said bridge shall forever after remain free to all travel whatsoever.

SEC. 6. This Act shall take effect and be in force from and after its passage.
