An Act to authorize and empower the City of Hastings to issue Bonds for Railroad purposes.

Storios 1. Authority to form Bonds to build a branch Railroad.

Power to dispute of the Bond t. Vote of the citizens to be taken upon the question of leading

the credit of the city. Form of ballot.

Be it exacted by the Legislature of the State of Mirnesota:

Section 1. That for the purpose of constructing a railroad from the City of Hestings, in the County of Dakota, in Authority to in the State aforesaid, to a point of junction on the line of the see bonds Minneapolis and Cedar Valley Railroad, the Council of the said city shall have power to issue bonds under the corporate seal of the city, and the signatures of the Mayor and the City Clerk, to an amount not to exceed the sum of seventy five thousand dollars (\$75,000), to be issued in such denominations, and to be payable at such times and places as shall be by the said Council determined, and to bear interest at the rate of eight per cent per annum, payable semi-annually.

SEC. 2. That the said Council shall have power to loan, Power to displedge, hopothecate, negotiate, sell and dispose of, and in pass of bonds

any other manner whatsover, to apply the said bonds for the purpose aforesaid.

SEC. 3. That before any issue of bonds by the City Coun-Vote of any oil for the purpose aforesaid, the said Council shall, and are sens to be tohereby empowered to, authorize by ordinance an election to ken be held by the qualified electors of the said city, to determine whether the credit of the said city shall be leaned for the purpose aforesaid. The said ordinance shall declare the aggregate amount of bonds to be issued—the time and place of payment of the same, and the day of the said election. Every such election shall be held at the places, and in the manner, and the inspection, counting an i return of the votes thereat, shall likewise be made, in the manner provided by law for the annual election of the officers of the said city, and every elector qualified to vote at such annual election, shall be entitled to vote at each and every election herein provided for.

SEC. 4. That on the ballot to be cast by the voters at Perm of ballot every election, berein provided for, shall be written or printed the words, "For the Loan," or "Against the Loan,"

and a majority of affirmative votes as aforesaid shall be held to authorize the loan of the credit of the city, for the purpose and in the manner in this Act declared.
