An Act to Legalize the Record of the Town of Richmond.

SECTION 1. Survey and plat of town legalized.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That survey and plat of the town of Richmond, in the county of Stearns, as recorded in the office of Register of Deeds in the year A. D. 1857, be and the same is hereby legalized, and all records made prior to A. D. 1857, are declared to be void. Survey and plat of town legalized

CHAPTER COVII.

An Act to amend an Act entitled "An Act to Incorporate the Winona Ferry," Approved March 6th 1857.

SECTION 1. Requires Winons Ferry Company to organize within three months.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. That Section five of an Act entitled "An Act to incorporate the Winona Ferry," approved March sixth, one thousand eight hundred and fifty-seven, be and the same is hereby amended so as to read as follows :

SEC. 5. That if said corporation shall not organize within three months after the passage of this Act, and be in readiness with a good and sufficient boat or boats to perform their duties as herein required, on or before the first day of July, A. D. 1860, then this Act shall be void.
