

SEC. 2. That said commissioners or any two of them shall meet at such time and place to commence such location as they may deem most advisable: *Provided, however,* That said location must be made within six months from and after the passage of this act.

Meeting

SEC. 3. It is hereby made the duty of the above-named commissioners to report the location and deposit a copy of the map of the survey of said road with the Register of Deeds of each of the counties through which said road passes.

Deposit copy

SEC. 4. If any of the commissioners named in this act shall neglect or refuse to act after being notified of the time appointed for the commencement of the road, then his associate commissioner or commissioners may select and appoint some other person to act on said board; and the person or persons so appointed shall perform all the duties, with all the powers he or they would have possessed if named in this act.

Appoint substitute

SEC. 5. The expense of locating said road shall be paid by the counties through which said road may pass.

Expenses

SEC. 6. This act shall take effect from and after its passage.

## CHAPTER XXI.

*An Act to provide for the laying out of a State Road from the north shore of Lake Superior to Graham's Point on the Red River of the North.*

- SECTION 1. Board of Commissioners.  
 2. Meeting of Board.  
 3. Deposit copy of survey with Registers of Deeds.  
 4. Per diem.  
 5. Take effect.

*Be it enacted by the Legislature of the State of Minnesota :*

**Commissioners** SECTION 1. That David Gilman, Alexander Kinkead, Geo. W. Sweet, John H. Liniman and John H. Schoonover are hereby appointed Commissioners to locate and mark a State road from some eligible point on the north shore of Lake Superior by the best route to Graham's Point on the Red River of the North.

**Meeting** SEC. 2. That said commissioners, or a majority of them, meet at the town of Watab on the third Monday in May A. D. 1858, or as soon thereafter as practicable, and proceed to lay out and mark said road by the most direct and feasible route.

**Deposit copy of survey** SEC. 3. It is hereby made the duty of the above-named commissioners to deposit a copy of the map of the survey of said road with the Register of Deeds of the counties through which said road passes.

**Per diem** SEC. 4. The said commissioners shall receive three dollars per day for said service, to be paid by the several counties through which said road may pass.

**Take effect** SEC. 5. This act shall take effect from and after its passage.
